## FUND OBJECTIVE

The Fund seeks to generate a return for investors mainly through investment in a portfolio of liquid asset backed securities (ABS) and corporate floating rate notes (FRNs)

- Aims to add value principally through a focus on daily liquidity management, via a high allocation to AAA and AA rated instruments with short maturities

## FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in June, ending with a 99% weighting to AAA-rated assets. European structured credit gained further ground, owing to solid technical underpinnings as issuance levels remained strong. US structured credit also posted gains as investors comfortably absorbed new issues and the technical backdrop remained favourable. Despite signs of a slowing US economy, US labour market strength and strong retail sales data underpinned optimism that any recession would be mild. In addition, defaults in the autos sector remain below historic levels, despite a further modest increase in delinquencies. Prime residential mortgage-backed securities and auto issuers contributed most strongly to performance in June. We were opportunistic in our purchases.

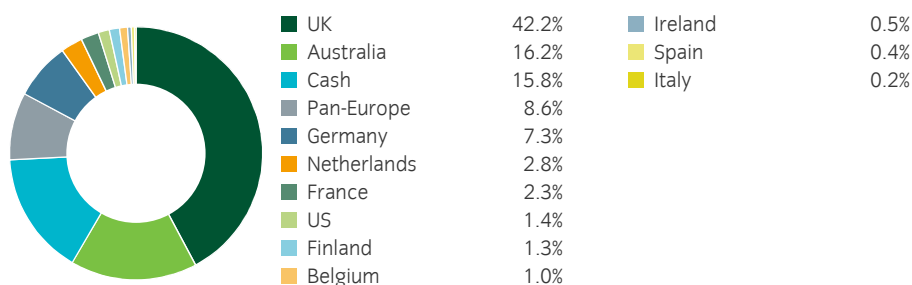

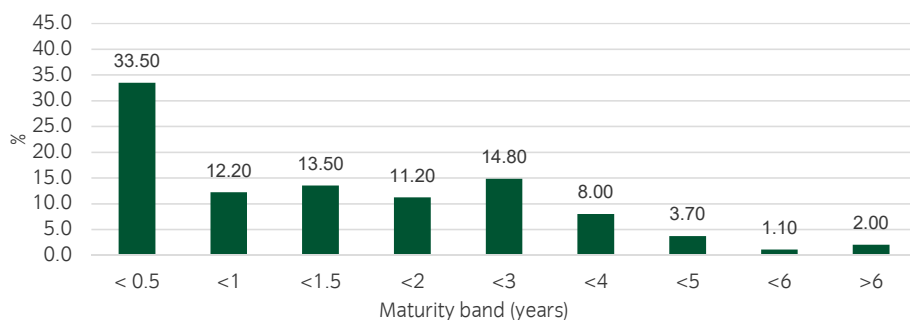

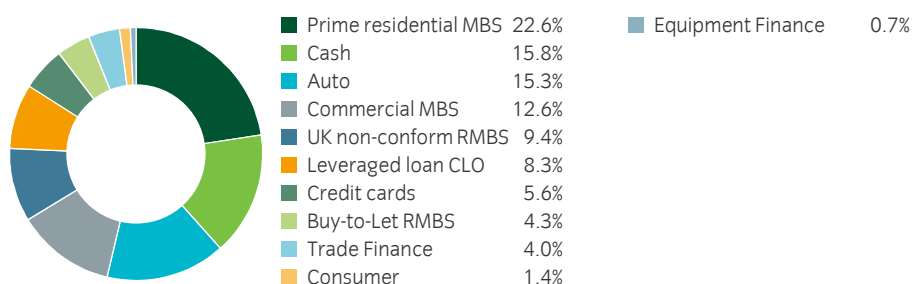
