FUND OBJECTIVE

The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

FUND SUMMARY

- Actively managed to aim to deliver security, liquidity and attractive cash yields comparable to short-dated money market interest rates
- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks
- Fitch rated AAAs/S1, Moody's rated Aaa-mf
- Qualifying Money Market Fund (QMMF) for regulated Client Money. Investors should make their own independent determination as to whether the Fund meets the QMMF criteria before investing

FUND MANAGER COMMENTS

Annual inflation declined from 6.7% in September to 4.6% in October mainly due to a fall in energy prices. The Bank of England kept its base rate at 5.25%. Third-quarter GDP growth was zero, according to a preliminary estimate. The manufacturing purchasing managers' index remained in contractionary territory for the sixteenth consecutive month, but rose from 44.8 in October to 47.2 in November. In markets, SONIA remained unchanged at 5.19%, while the 2-year gilt yield declined from 4.77% to 4.63% and the 5-year gilt yield decreased from 4.46% to 4.22%. While the inflation outlook appears positive and markets are pricing no further rate hikes, selective term investments are being sought, especially over year end. At the same time positioning will focus on upcoming central bank meetings. The weighted average maturity of the Fund was 16 days at the end of October and 19 days at the end of November.

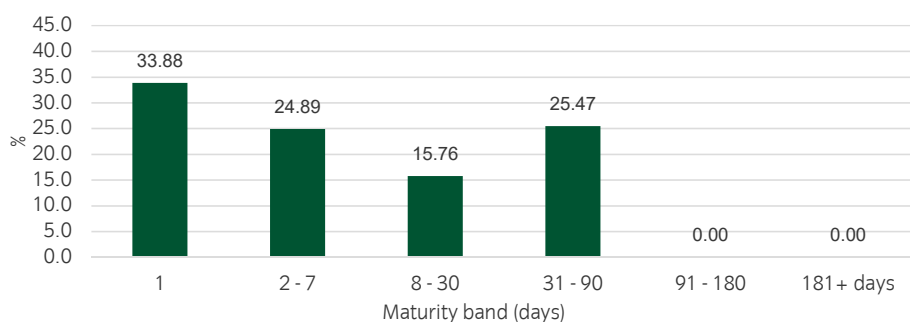

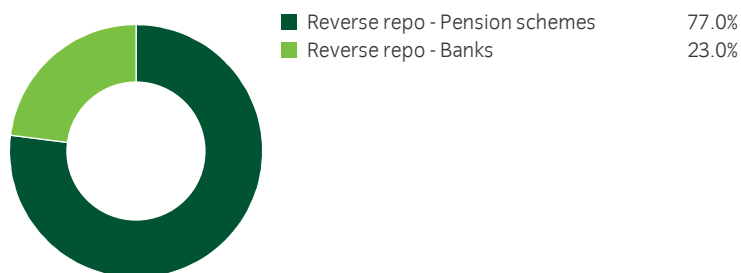
