FUND MANAGER COMMENTS

The Fund posted further gains in July, extending its outperformance of the cash benchmark and the CS Western European Institutional Loan Index on a year-to-date basis. In July, leveraged loans continued to rally, due to positive economic data, strong demand for collateralised loan obligations and subdued primary issuance. The European default ratio edged higher to 1.5%, while the distress ratio remained steady at 3.37%. Issuance was robust and amounted to €3.5 billion. In addition, refinancing and extension transactions totalled an additional €5.1 billion. We used profits from our position in Parkdean Resorts to buy a term loan from Arconic in the primary market. In our view, leveraged loans will continue to be supported by strong technicals and vigorous extension transactions volumes. Leveraged loans now offer select investment opportunities. We will continue to use the current opening to increase the Fund's carry and rotate into defensive companies with higher margins.

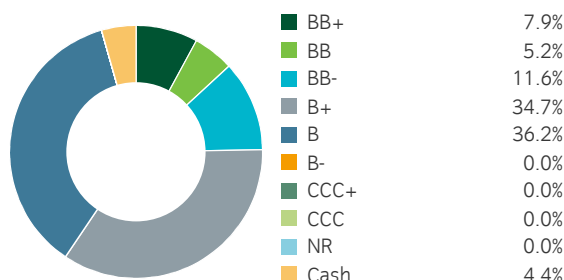

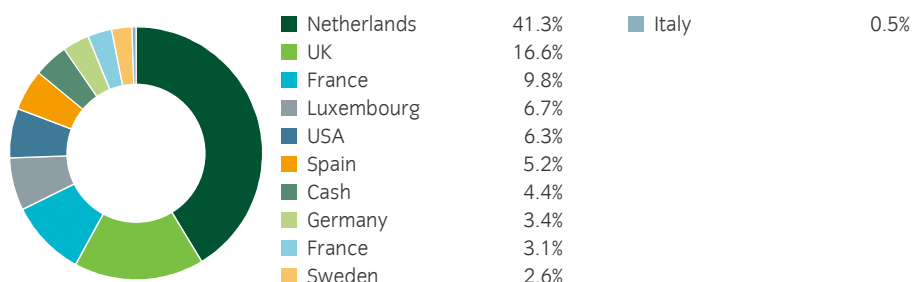

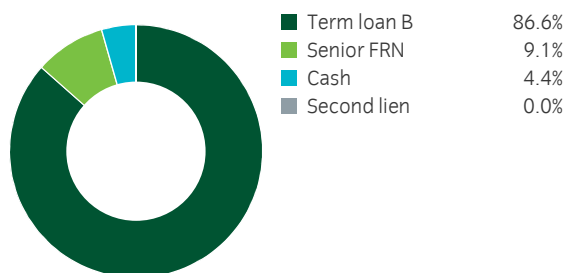
GEOGRAPHY
