FUND MANAGER COMMENTS

US annual inflation declined to 3.2% in October from 3.7% in September as energy costs fell by 4.5% year on year. The US Federal Reserve maintained the target range for the fed funds rate at 5.25-5.50% at its November meeting. The US economy expanded at an annualised rate of 5.2% in the third quarter. The manufacturing purchasing managers' index declined from 50.0 in October to 49.4 in November. In markets, the Secured Overnight Financing Rate declined from 5.35% to 5.33%. While the inflation outlook appears positive and markets are pricing no further rate hikes, selective term investments are being sought, especially over year end. At the same time positioning will focus on upcoming central bank meetings. The weighted average maturity of the Fund was 21 days at the end of October and 18 days at the end of November.

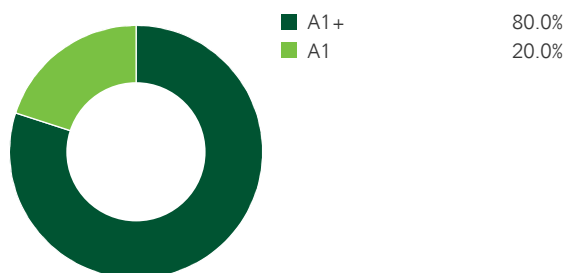

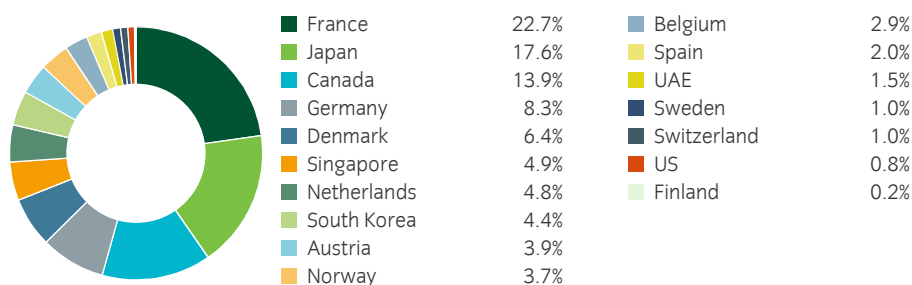

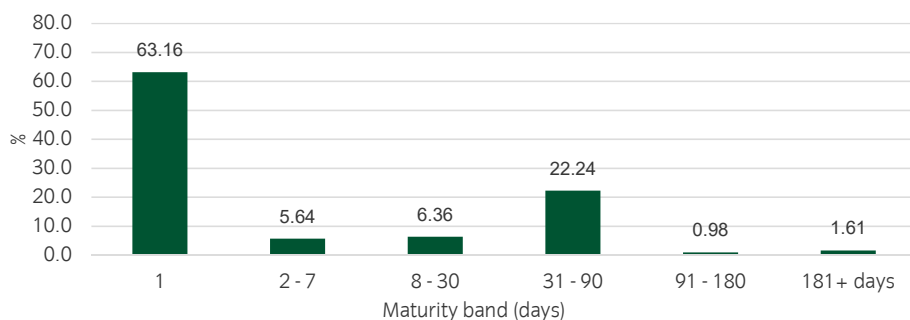

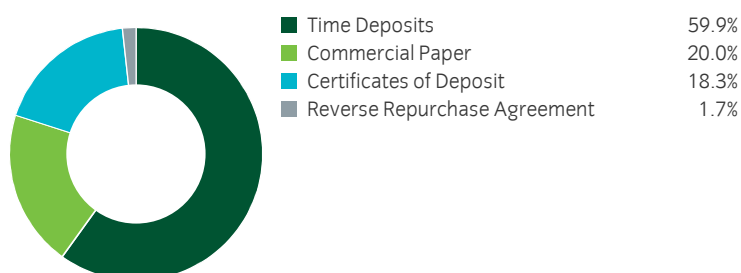
GEOGRAPHY
