## FUND MANAGER COMMENTS

The Fund generated a positive return in June. Risk free assets and credit spreads posted gains. The Fund's credit positioning was positive. Our long positions in loans and asset-backed securities added to performance. The Fund's duration positioning also contributed. We took profit from our short position in 5-year German Bunds and added a short position in Australia. Country selection proved beneficial. We took profit from our long position in New Zealand relative to Australia, and our Italy versus Germany and Greece relative to France positions. The Fund's currency positioning was a small positive. Our emerging market positions posted gains. The Fund's swap spread position added to performance. In contrast, our yield curve positioning had a negative impact on performance. We added a steeper position in the UK. Finally, our inflation positions detracted from performance. We continue to run our long position in 30-year US inflation swaps versus Europe.

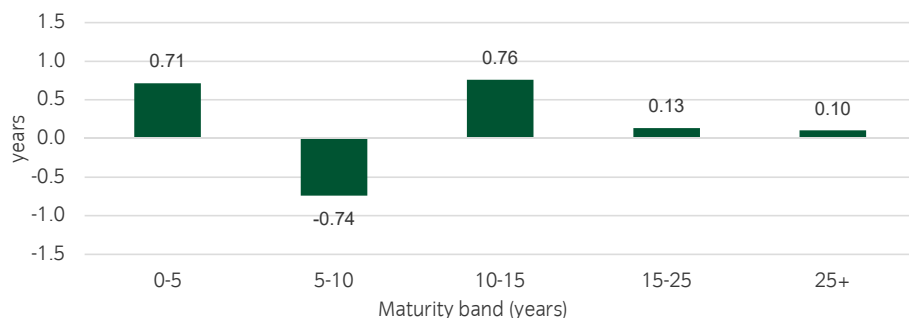

## DURATION EXPOSURE BY MATURITY

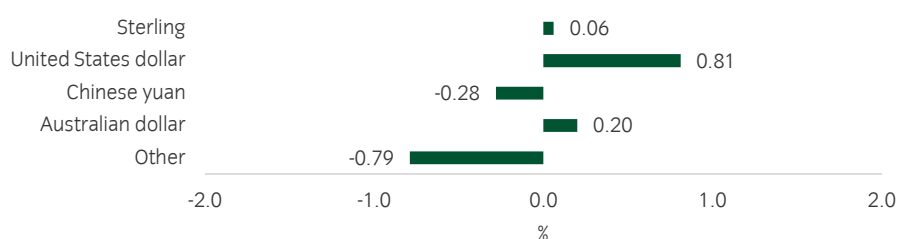
