FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in December. Risk assets rallied on hopes of a soft landing and rate cuts in 2024. European structured credit performed well. Higher beta classes outperformed again. However, the senior market also posted strong gains. Investor demand outweighed thin supply, aiding the technical backdrop. It was a quiet month for issuance, in line with the seasonal pattern, albeit the January pipeline is expected to be healthy. US structured credit posted gains, against limited supply and very strong demand in secondary markets. Higher beta sectors, including commercial mortgage-backed securities, outperformed, as concerns around financing costs subsided. December was quiet on the lending side. Performance was broad-based, with collateralised loan obligations contributing to carry. Our outlook for asset-backed securities remains positive, due to robust technicals, dovish central bank signals and attractive valuations relative to corporate credit

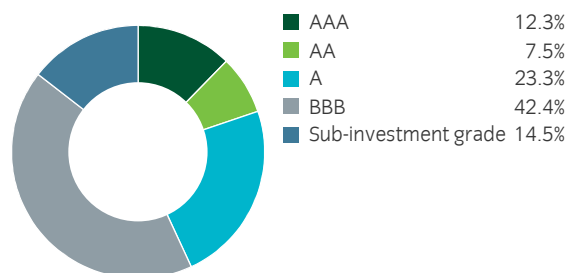

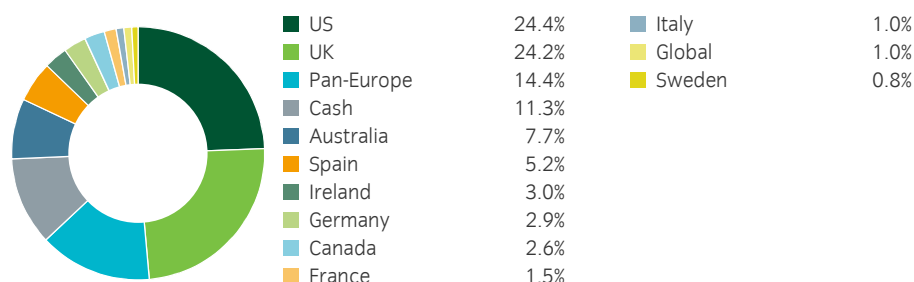

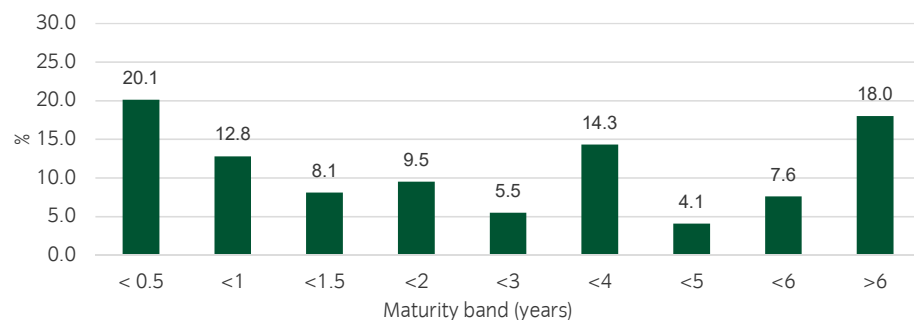

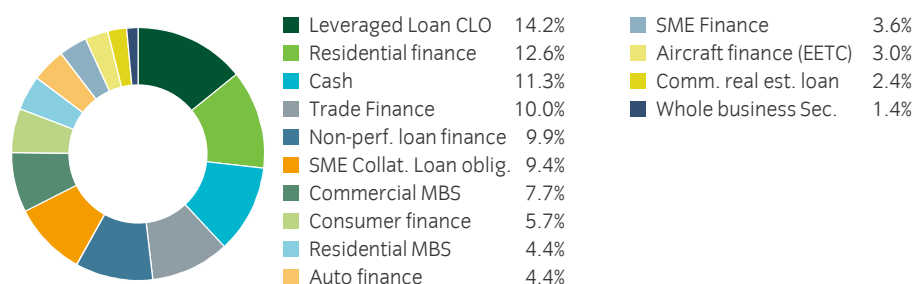
GEOGRAPHY
