FUND MANAGER COMMENTS

The Fund posted further gains during the month, although returns were marginally below its cash benchmark. In June, improved risk appetite underpinned a continuing rally in leveraged loans before several profit warnings and earnings downgrades later in the month unsettled investors. Year-to-date, the European leveraged loan market has recorded its highest returns for any comparable half-year period since 2009. Although new issue volumes remained light during June, we participated in refinancings from IPD and Nordic group Assemblin as well as the buyout of chemicals company Univar. In the secondary market, we sold our holding in Miller Homes on credit concerns and switched our position in ION Analytics into the new IPD floating-rate note. In our view, current yields on leveraged loans adequately compensate for the credit risk and offer select investment opportunities. We will continue to focus on increasing the Fund's carry and rotate into defensive companies with higher margins.

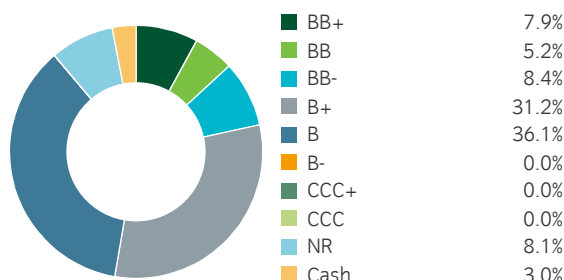

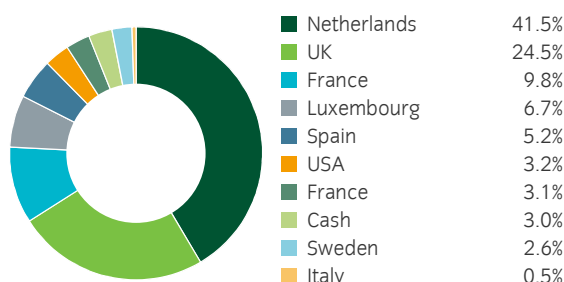

CREDIT RATING



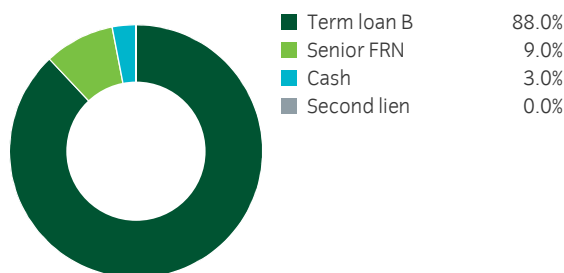
GEOGRAPHY
