FUND MANAGER COMMENTS

Eurozone inflation declined to an annual rate of 4.3% in September, from 5.2% in August, according to a preliminary estimate, as energy prices fell. The European Central Bank raised interest rates by 25 basis points, taking the main refinancing operations rate to 4.5%. Second quarter GDP growth was downgraded to 0.1% from a second estimate of 0.3%. The manufacturing purchasing managers' index fell from 43.5 in August to 43.4 in September. In markets, 1-month EURIBOR rose from 3.64% to 3.85% over September, while the 3-month rate increased from 3.79% to 3.95%. We added certificates of deposit and commercial paper from Bank of America, OP Corporate Bank and Santander Consumer Finance. We bought floating rate notes from TD Bank, Bank of Nova Scotia and LeasePlan, among others. We will continue to position for further central bank rate hikes, with risks around the stickiness of inflation. The weighted average maturity of the Fund was 56 days at the end of August and 65 days at the end of September.

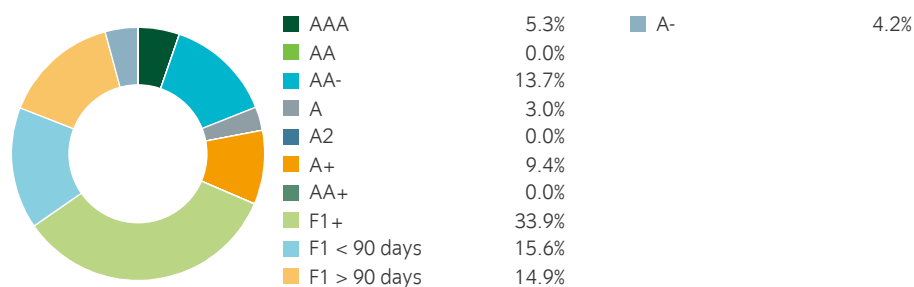

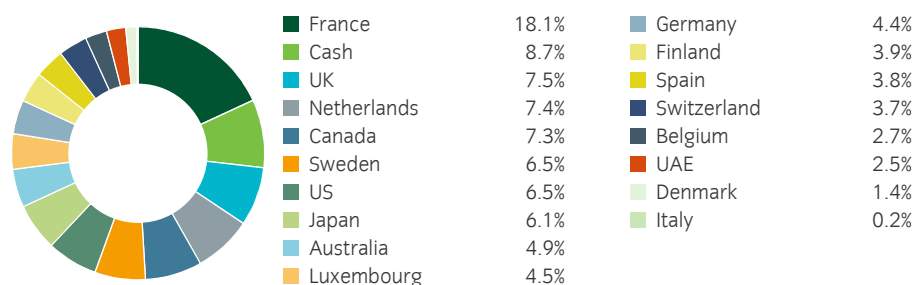

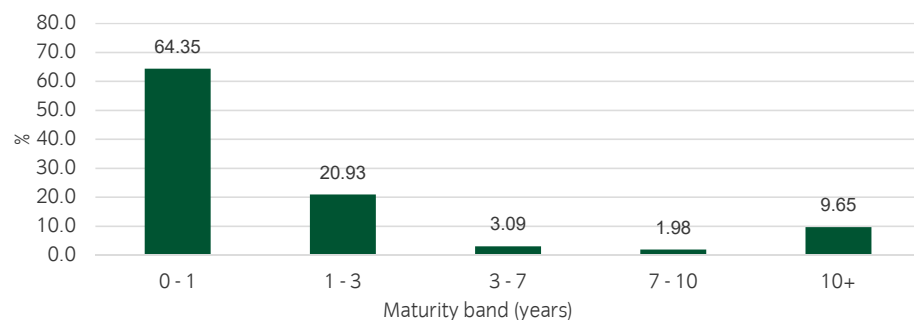

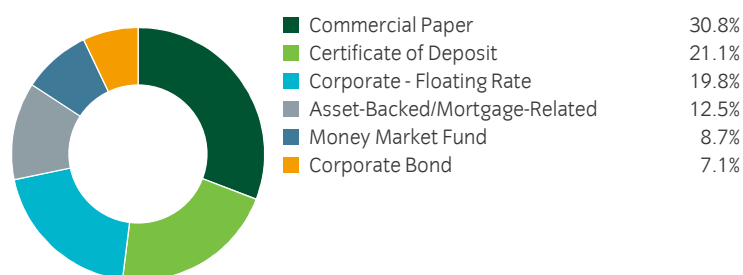
GEOGRAPHY
