FUND MANAGER COMMENTS

US annual inflation rose by 10bp to 3.2% in February. The US Federal Reserve kept the target range for the fed funds rate at 5.25-5.50%. In a final reading released in March, the economy's fourth quarter annualised growth rate was revised up by 20bp to 3.4%. The Manufacturing Purchasing Managers' Index edged down from 52.2 in February to 51.9 in March. In markets, the Secured Overnight Financing Rate remained at 5.32%. While the inflation outlook appears positive and investors are pricing in no further rate hikes, selective term investments were favoured. Positioning will be determined by upcoming central bank meetings. The weighted average maturity of the Fund was 22 days at the end of February and 23 days at the end of March.

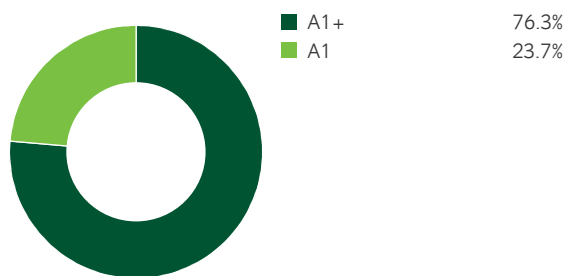

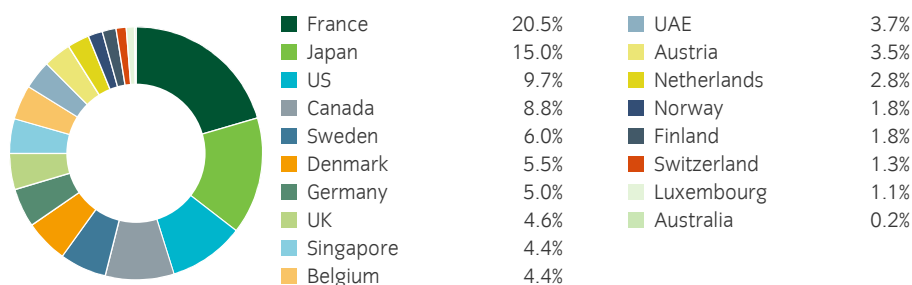

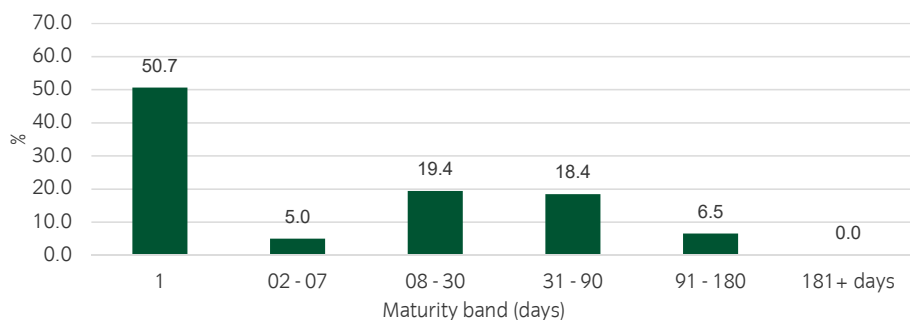

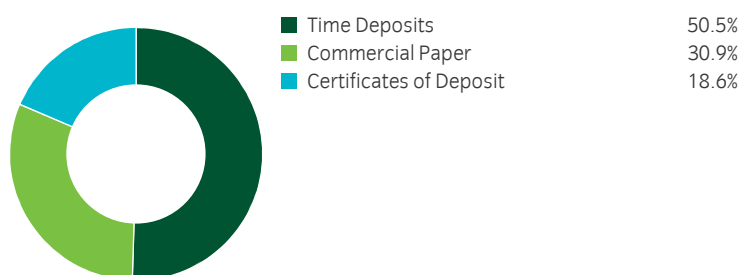
GEOGRAPHY
