FUND OBJECTIVE

The Fund seeks to produce an interest rate based return, primarily through investment in a portfolio of asset-backed securities (ABS) and corporate floating rate notes (FRNs)

FUND SUMMARY

- Actively managed to aim to deliver positive absolute returns in excess of a cash benchmark
- Aims to add value principally through AAA and AA rated securities, with a bias to prime residential mortgage-backed securities
- Rigorous, disciplined investment process aiming to deliver precision and diversification
- The Fund was previously named the LIBOR Plus Fund. It was renamed the High Grade ABS Fund on 2 January 2020.

FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in June, ending with a running yield of 182bp ahead of one-month SONIA and a 77% weighting to AAA-rated assets. Despite the uncertain global economic outlook, risk assets gained as technology stocks continued to rebound strongly amid optimism the rally can be sustained in the near term. European structured credit moved higher, due to solid technical underpinnings, as issuance levels remained strong. US structured credit also posted gains as investors comfortably absorbed new issues and the technical backdrop was supported by tightening spreads. Despite signs of a slowing US economy, US labour market strength and strong retail sales data underpinned optimism that any recession would be mild. In addition, defaults in the autos sector remain below historic levels, despite a further modest rise in delinquencies. Prime residential mortgage-backed securities and leveraged collateralised loan obligations contributed most strongly to performance in June. We were opportunistic in our purchases.

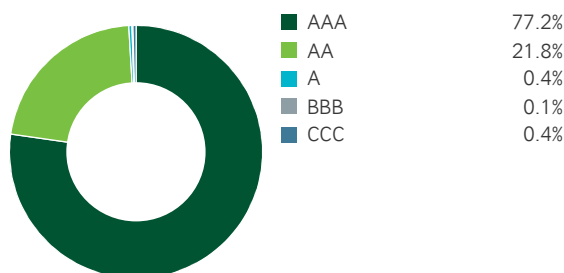

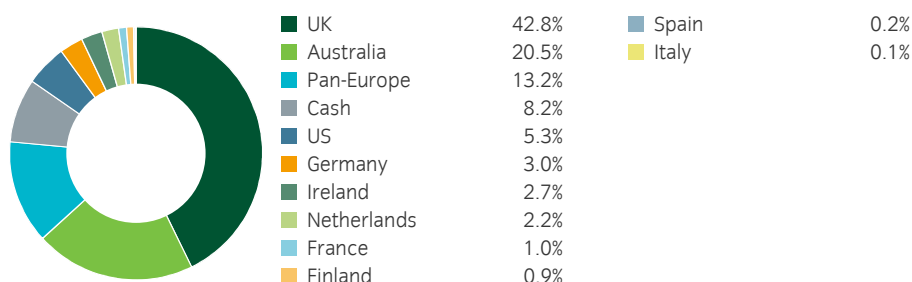

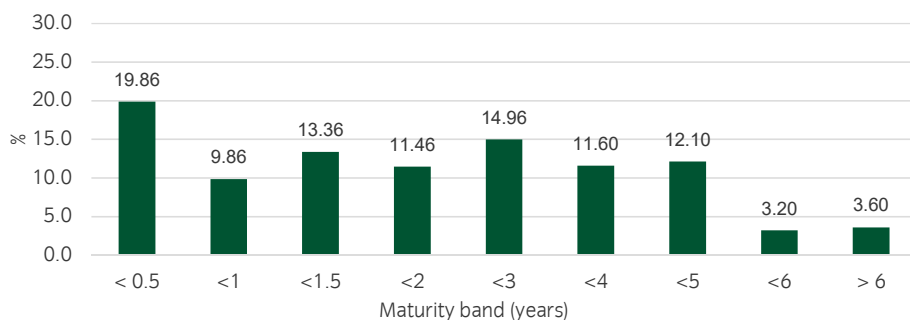

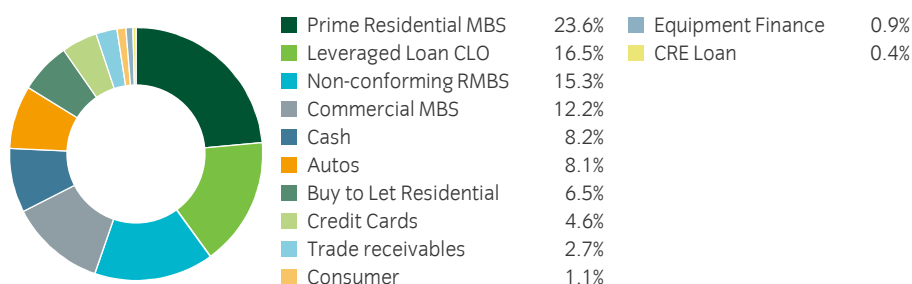
GEOGRAPHY
