
### **FUND MANAGER COMMENTS**

Annual inflation in the eurozone remained flat month on month at 2.4% in April, according to a preliminary estimate. The European Central Bank left interest rates unchanged in April. The Manufacturing Purchasing Managers' Index fell from 46.1 in March to 45.7 in April. According to an initial estimate, first-quarter GDP in the eurozone grew by 0.3% on a sequential basis. In markets, 1-month EURIBOR increased from 3.85% to 3.87%, while the 3-month rate declined from 3.89% to 3.82%. We bought certificates of deposit and commercial paper from Goldman Sachs and BNP Paribas. We bought floating-rate notes from SEB. Positioning will be determined by upcoming central bank meetings. The weighted average maturity of the Fund was 67 days at the end of March and 67 days at the end of April.




