FUND MANAGER COMMENTS

Annual inflation declined from 3.4% in February to 3.2% in March. The Manufacturing Purchasing Managers' Index fell from 50.3 in March to 49.1 in April. The Services Purchasing Managers' Index increased from 53.1 in March to 55.0 in April. Retail sales increased by 0.8% year-on-year in March. In markets, SONIA remained unchanged at 5.19%, the 2-year gilt yield rose from 4.16% to 4.42% and the 5-year gilt yield increased from 3.82% to 4.18%. We bought certificates of deposit and commercial paper from Barclays, BNP Paribas, United Overseas Bank, Canadian Imperial Bank of Commerce, Credit Agricole, ANZ, Nordea, Goldman Sachs, National Australia Bank and Banco Santander. We bought floating-rate notes from Westpac and Commonwealth Bank of Australia. We bought UK Treasury bills. The weighted average maturity of the Fund was 45 days at the end of March and 42 days at the end of April.




