## FUND MANAGER COMMENTS

The Fund generated a negative return in April. Risk free assets remained volatile following the tariff announcements. Our long corporate credit position was a small negative, while long positions in asset-backed securities detracted. Our relative value positions had a mixed effect. Euro-denominated assets outperformed their US dollar-denominated peers, but credit default swaps underperformed cash. Duration positioning was a negative, as our short position in Japan detracted. We closed the position at a profit. Yield curve positioning detracted, driven by our flattener positions in Japan. Intra-Europe country selection had a neutral impact. Our cross-market positioning worked well, due to our position in Brazil relative to US Treasuries. Inflation positions were a positive, resulting from our short position in sterling-denominated 10-year inflation swaps. Currency positioning detracted, driven by our positions in the Swedish krona, the Swiss franc and the Canadian dollar.

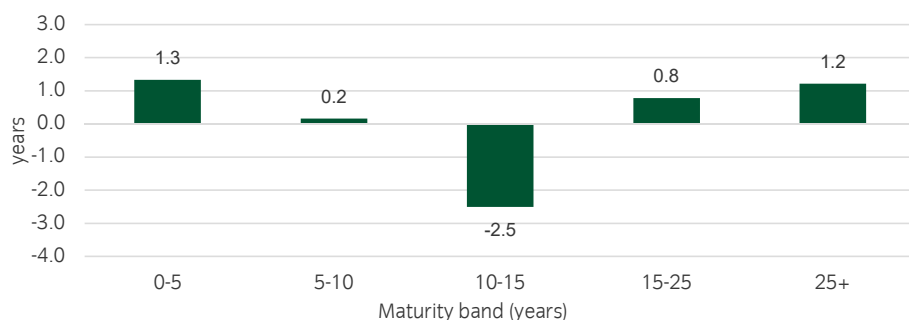

## DURATION EXPOSURE BY MATURITY

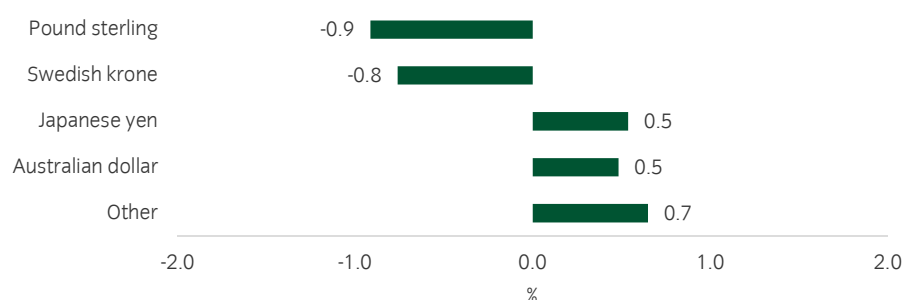
