SETTING UP YOUR ACCOUNT

- The Prospectuses, application forms and KIID's (Key Investor Information Document) can be obtained from our website (www.insightinvestment.com) using the "Contact us page" found in the Literature Library or by speaking to your Insight contact
- On your application form, please identify the share class(es) in which you wish to invest. You can check this with your contact at Insight Investment
- The amount may be left blank if you want to open the account and invest at a later date
- Applications received after 12 noon on any dealing day (as set out in the prospectus) will be processed on the next dealing day
- All application forms should be sent with an authorised signatory list and anti-money laundering documentation in line with the requirements detailed on the appropriate form together with a coverall renunciation to:

- If you have sent your application by fax, you are required to provide original documentation to the same address. When faxing your dealing instructions, please ensure that it has been received and accepted by Insight Investment by calling the number overleaf.
- **Failure to provide the original documentation will result in redemption payments being withheld**

METHOD OF PAYMENT

Monies will be required by settlement date, failure to do so may result in interest being charged. Payment can be made electronically to the appropriate settlement bank account. Subsequent applications and redemptions can be made by fax or telephone before 12 noon on any dealing day.

Please note: we are unable to accept payments from third parties.

Your payment should be made in one sum equal to the investment amount and net of any bank charges.

Payments should be made in the relevant fund currency unless previously agreed with your Insight contact and be paid for value on the contractual settlement date of your trade. Payments which cannot be allocated will be returned to your bank within 10 days.

Should you require details of the settlement bank account then please contact your Insight Investment contact.

If a partial redemption results in the remaining holding being below the minimum holding, a full redemption will be made and any dividends subsequently paid will be paid out.
