## FUND MANAGER COMMENTS

Markets reassessed their outlook for rates in January, pushing back the start of the easing cycle to later in 2024 as the global growth data was generally better than expected. This put upward pressure on bond yields, but not sufficiently to prevent gains in most equity markets. Against this backdrop the fund generated a positive return. Our broad equity holdings were the main driver of returns, and we increased our exposures over the month. Notable gains in the US and Japan outweighed a negative return in China. In fixed income, our low duration helped to insulate performance, but our holdings in government bonds and credit generated a small negative return. Higher rates also negatively impacted infrastructure markets, but this was counterbalanced to a degree by gains in commodity holdings. Within total return strategies, currency-based relative value trades performed well, as did dividend futures. We added a selection of upside option trades and increased the size of an Asian currency strategy over the month.


## 5 YEAR ANNUALISED GROSS PERFORMANCE (%)




