
### **FUND MANAGER COMMENTS**

The Fund outperformed its cash benchmark in April, ending with a 80% weighting to AAA-rated assets. Risk assets were subdued during the month, due to low market volatility. European structured credit continued to perform well. UK residential mortgage-backed securities (RMBS) outperformed the rest of the sector, while European collateralised loan obligations (CLOs) performed more strongly than their US counterparts. April saw sustained issuance across several countries and sectors, owing to a recovery in capital market conditions. US structured credit also posted gains across all sectors. Over the month, the subprime automotive and unsecured consumer sectors outperformed, as delinquencies and losses stabilised. Prime RMBS and CLOs contributed most strongly to performance in April. We deployed capital into prime RMBS in Australia and the UK in the primary market, and increased our exposure to automotive credit in Europe.




