FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in May, ending with a 79% weighting to AAArated assets. Risk assets performed poorly over the month, due to US debt ceiling negotiations, rate rises, concerns over US regional banks and signs of a slowing global economy. European structured credit continued to perform well, owing to strong technical and fundamental underpinnings. May saw strong issuance, with major UK banks returning to the market. In contrast, US structured credit was more mixed. Over the month, prime and subprime automotive loans, fleet lease, floorplan and private student loan spreads tightened, while unsecured consumer, automotive lease and rental car spreads widened. Delinquencies increased across all consumer sectors. Prime residential mortgage-backed securities and leveraged collateralised loan obligations contributed most strongly to performance in May. We were opportunistic in our purchases.




