FUND MANAGER COMMENTS

The Fund generated a positive return in July. Risk free assets were volatile, while credit spreads tightened. The Fund's credit positioning was positive. Our long positions in loans and asset-backed securities contributed. Country selection proved beneficial, owing to our Italy versus Germany and Greece relative to France positions. Our emerging market positions posted gains, despite rising yields in developed markets. The Fund's swap spread position added to performance. Our yield curve positioning also had a positive impact, driven by the steeper position in UK interest rate swaps. We added steeper positions in Germany and the UK, which performed well. The Fund's duration positioning detracted, due to our long position in New Zealand. Our inflation positions also had a negative impact on performance, resulting from our short position in euro-denominated inflation swaps. The Fund's currency positioning was negative, due to our position in the US dollar relative to the renminbi.

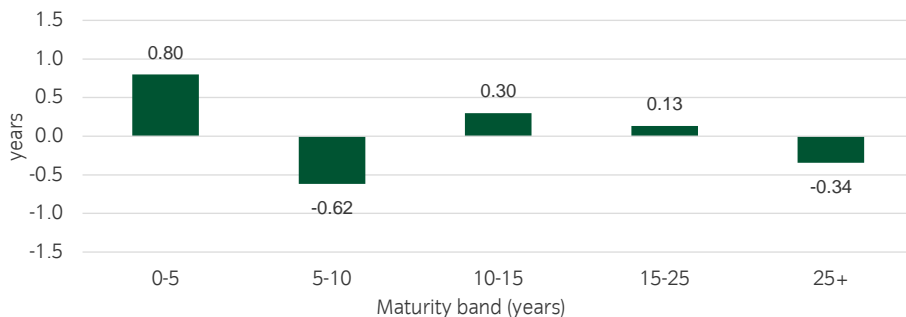

DURATION EXPOSURE BY MATURITY

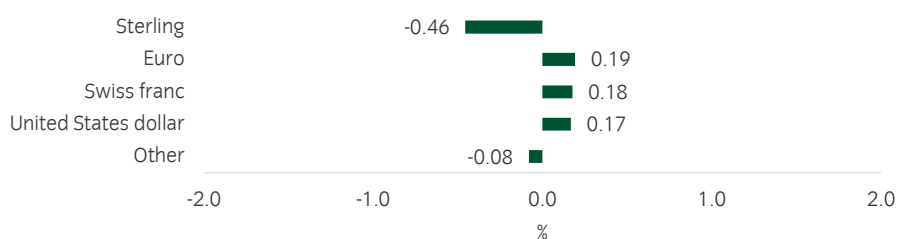
