
#### **FUND MANAGER COMMENTS**

The Fund generated a positive return in October. Risk free assets sold off sharply and credit spreads widened. The Fund's credit positioning was negative. Our long positions in loans and asset-backed securities were neutral. Our long positions in European investment grade credit relative to European high yield credit and US investment grade credit detracted. Country selection proved detrimental, owing to our short position in Canada relative to Australia and New Zealand. Our emerging market positions were neutral, despite rising yields. Our yield curve positioning was neutral, as our steepener positions in the US and Europe were offset by our flattener position in Japan. The Fund's duration positioning was also neutral. We increased our long position in US Treasuries as yields rose. Our inflation positions had a positive impact on performance, resulting from our short position in eurodenominated inflation swaps. The Fund's currency positioning was neutral.


