
FUND MANAGER COMMENTS

The Fund generated a positive return in December. Risk free assets posted gains and credit spreads rallied. The Fund's credit positioning was positive against spread tightening. Our long positions in loans and asset-backed securities contributed. Country selection proved beneficial, owing to our long position in Italy versus Germany and our long positions in Sweden, Australia and New Zealand relative to Canada and Germany. The Fund's duration positioning was positive. We took profits from our long position in US Treasuries. Our emerging market positions were positive, as risk free assets rallied. Swap spreads also contributed positively. Iinflation positions were neutral. In contrast, our relative value credit positions detracted, as credit default swaps and US dollar-denominated assets outperformed physical credit and euro-denominated assets. Yield curve positioning detracted. Finally, the Fund's currency positioning was positive, owing to our short position in the US dollar.

DURATION EXPOSURE BY MATURITY




