FUND MANAGER COMMENTS

The Fund generated a positive return in August. Government bonds posted gains, but credit spreads widened. The Fund's long credit positioning was a negative. Our long positions in loans and asset-backed securities contributed. Relative value credit positions were modestly positive. European investment grade credit underperformed high yield credit, and we increased our decompression position. Credit default swaps underperformed cash and credit, and we closed the position. Country selection proved neutral, as positive performance from our short position in Canada relative to the US, Australia and New Zealand was offset by our long position in South Korea relative to US Treasuries. The Fund's duration positioning was neutral, with our long positions in the US and Europe contributing. The Fund's inflation positioning contributed. Yield curve and emerging market positioning added value. Currency positioning detracted, due to our short positions in the New Zealand dollar and the Swedish krone.

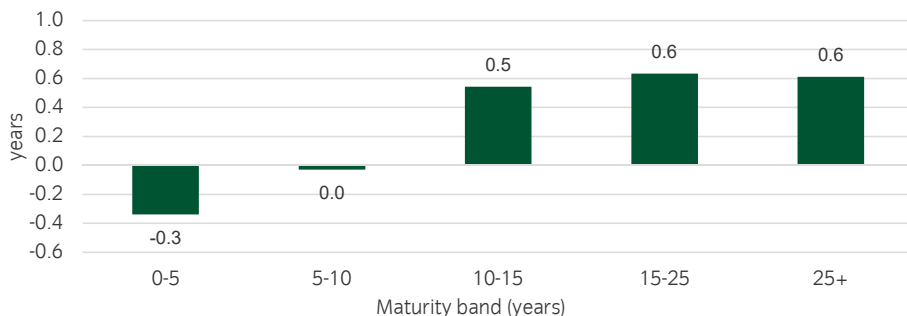

DURATION EXPOSURE BY MATURITY

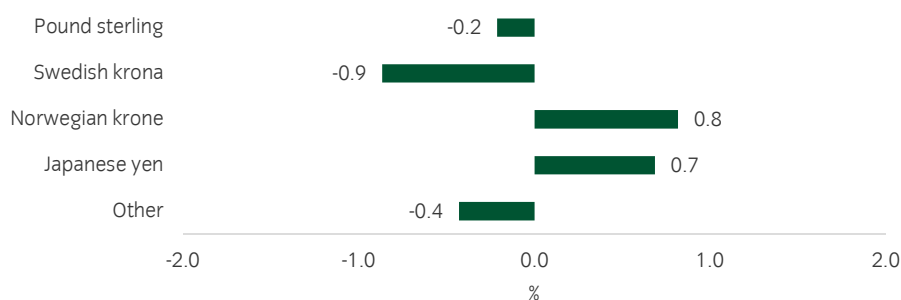
