
FUND MANAGER COMMENTS

The Fund generated a positive return in December. Risk free assets sold off due to concerns around inflation and monetary policy. The Fund's credit positioning was a small positive. Our long positions in loans and asset-backed securities contributed. Relative value credit positions were a positive, as euro-denominated assets outperformed their US dollar-denominated peers. Country selection contributed, driven by our short position in Sweden relative to Europe. We took profits from our long position in Spain relative to a short position in France. Duration positioning detracted due to our long position in UK gilts. The Fund's inflation positioning was a positive, resulting from our short position in sterling-denominated inflation swaps. Yield curve positioning contributed owing to our steepener position in the US. Our flattener position in Japan was a small positive. Our emerging market positioning detracted. Currency positioning contributed due to our long position in the US dollar.

DURATION EXPOSURE BY MATURITY


