## FUND OBJECTIVE

The Fund seeks to generate a return for investors mainly through investment in a portfolio of liquid asset backed securities (ABS) and corporate floating rate notes (FRNs)

## FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in July, ending with a 98% weighting to AAA rated assets. Risk assets were volatile due to softening economic data and an interest rate rise from the Bank of Japan. European structured credit performed well, as modest spread widening in higher beta asset classes was offset by carry. Issuance remained robust, but net growth is limited on a year-to-date basis. US structured credit saw subdued issuance relative to June, with spreads ending the month flat to modestly tighter. Despite expected volatility, we anticipate that investor demand and robust structures will result in continued spread tightening. Performance for the month was primarily driven by coupon income. Our outlook for asset-backed securities remains positive, due to strong inflows, investors desire to lock in elevated yields, plus robust structures should give spreads a bias tighter for the remainder of the year.

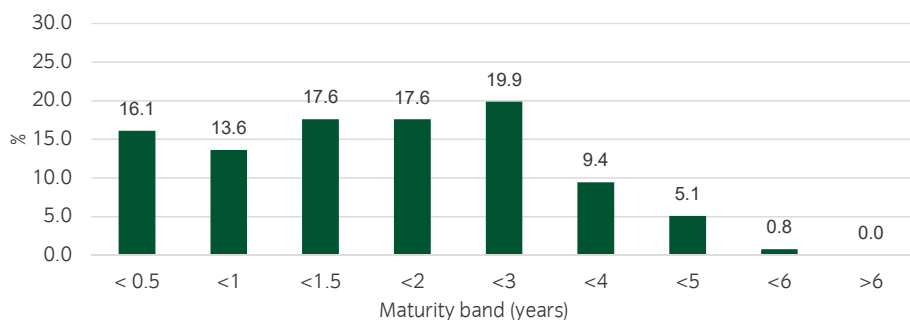

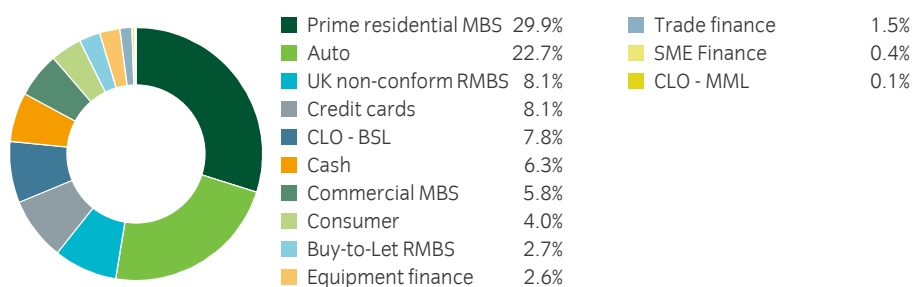
