## PERFORMANCE AIM

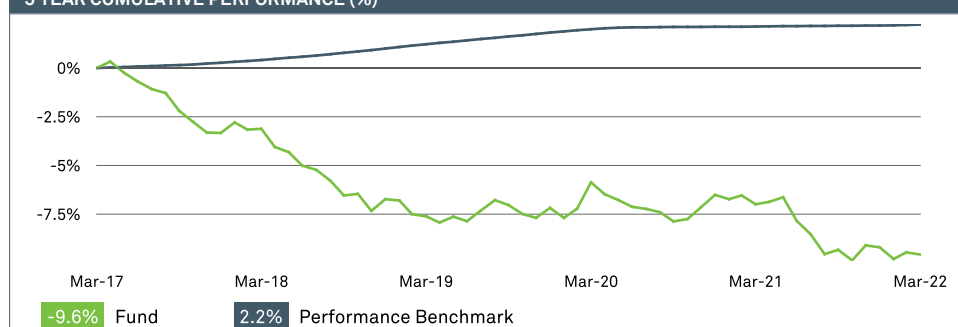

The Fund's benchmark is SONIA (90 day compounded) and the Fund shall measure its performance against this. In addition the Fund seeks to generate returns of up to SONIA (90 day compounded) + 4% gross of fees over an annualised five year period, whilst being mindful of the 12 month aim.

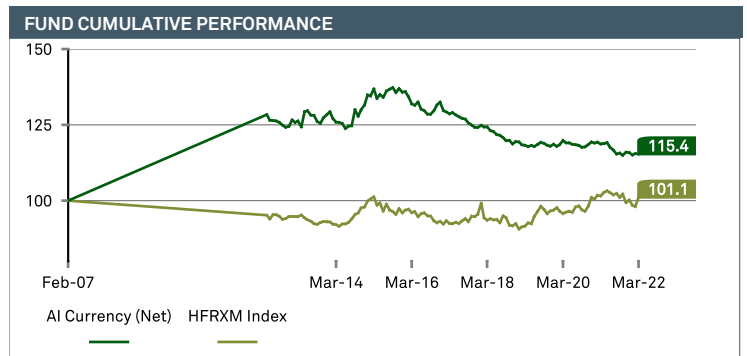
