The investment objective of the Fund is to provide attractive, positive, absolute returns in all market conditions.

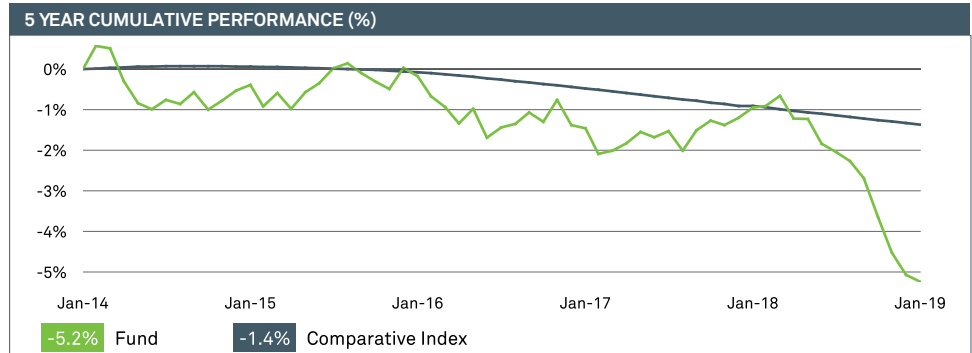
## PERFORMANCE AIM

The Fund aims to achieve its objective on a rolling 12 month basis through discretionary management and may employ a range of hedging techniques. In addition the Fund aims to target 3 month Euribid + 3% on a rolling annualised 5 year basis gross of fees and expenses. However, a positive return is not guaranteed and a capital loss may occur. It is an equity market neutral fund primarily investing in equity and equity derivatives. Each equity position is usually paired with a hedge with the aim of minimising unwanted risk and creating a market neutral position.
