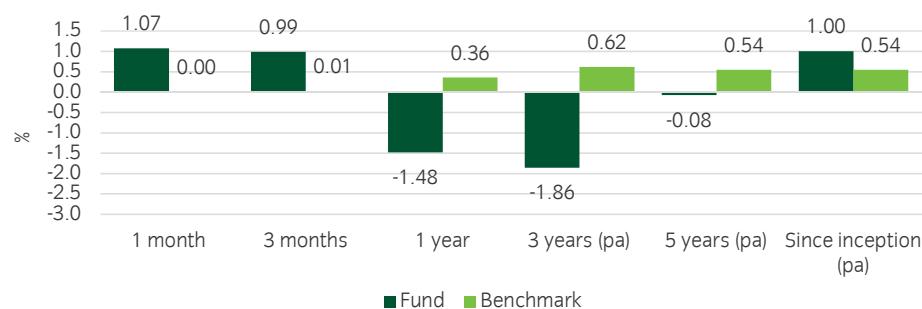
FUND OBJECTIVE

FUND MANAGER COMMENTS

The Fund generated a positive return, outperforming its benchmark. The main positive was our positioning in corporate credit. Although we have reduced our net exposure to a relatively modest level, we benefited from our tilt towards COVID-19-sensitive sectors, as well as our long 'basis' position in cash bonds held versus credit default swap indices. Country selection was also positive, as our long positions in both Italy and the US versus Germany, and our long US versus France position, performed well. In emerging markets, our long duration positions positively contributed, as did our long currency exposures. Our long position in loans performed well as spreads tightened, while European mezzanine asset-backed securities also made a small positive contribution. Our (Asian) currency positions had a marginally positive effect. However, our long duration position in 30-year US Treasuries detracted. Our yield curve flattener positions in Italy and Germany were also slightly detrimental.

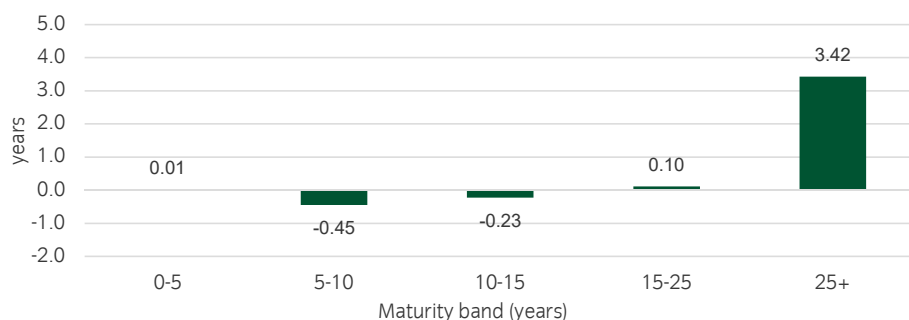

DURATION EXPOSURE BY MATURITY

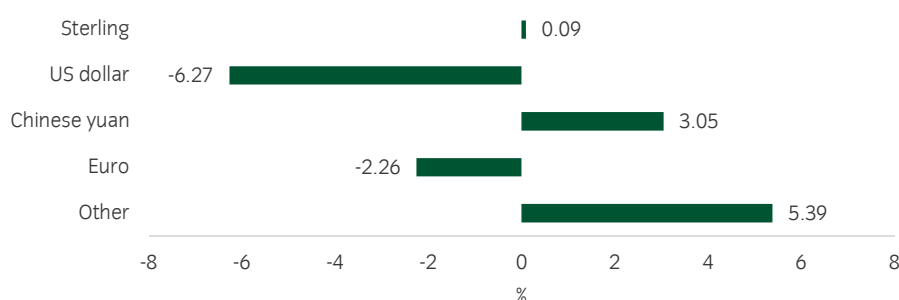
