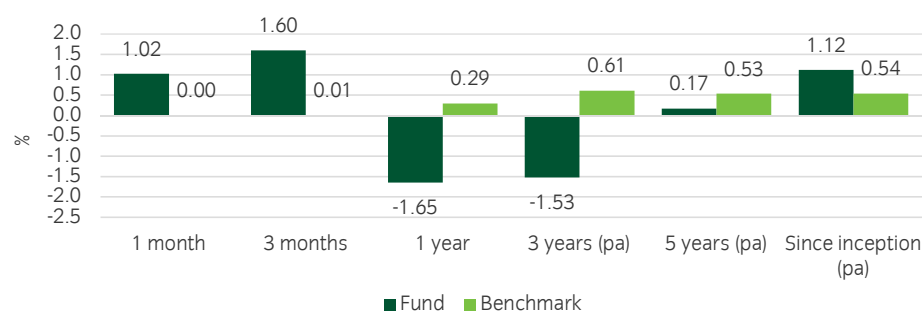
FUND OBJECTIVE

FUND MANAGER COMMENTS

The Fund generated a positive return, outperforming its benchmark. The main positive was our positioning in corporate credit. Although we have reduced our net exposure to a relatively modest level, we benefited from COVID-19-sensitive sectors and high yield, and our long 'basis' position in cash bonds held versus credit default swap indices. Our European mezzanine asset-backed securities exposure also made a positive contribution. Our long position in loans also performed well, along with high yield, as spreads tightened. In emerging markets, our long duration positions positively contributed, while our small long currency exposure was neutral. Our (Asian) currency positions had a marginally positive effect. Our yield curve flattener position in Germany also made a small positive contribution. However, country selection was marginally negative, largely due to underperformance from our long position in the US versus Germany in the first half of the month. Duration also marginally detracted.

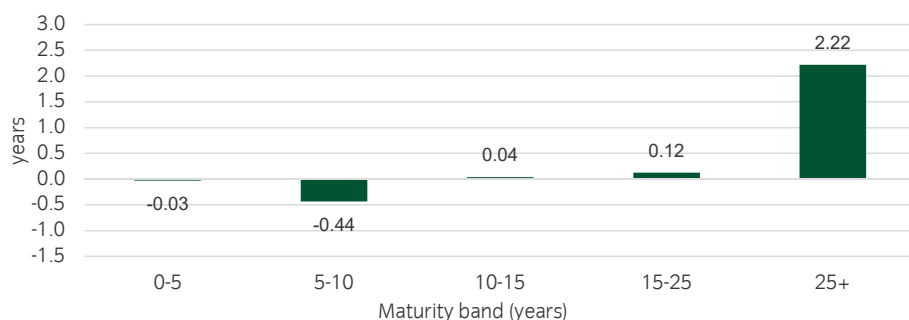

DURATION EXPOSURE BY MATURITY

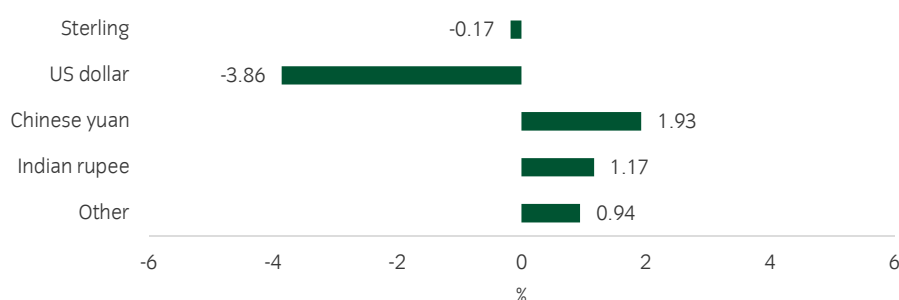
