FUND MANAGER COMMENTS

The Fund generated a positive return over the month, outperforming its benchmark. Our positioning in corporate credit was beneficial given our long physical credit versus short credit default swaps position. Our slight long position in corporates was also a positive. Allocations to asset-backed securities and loans generated small positive returns. In emerging markets, our long duration and currency positions contributed positively. Our currency positions were also a modest positive. In contrast, our duration position notably detracted due to having a short bias in US Treasuries as yields fell; our long position in China provided some offset as yields declined. Country selection was negative given a long position in Germany relative to the US as the latter outperformed. Our long position in Italy relative to Germany also detracted but our short position in UK Gilts relative to a long position in the US added value. Finally, our yield curve positioning generated a small profit.

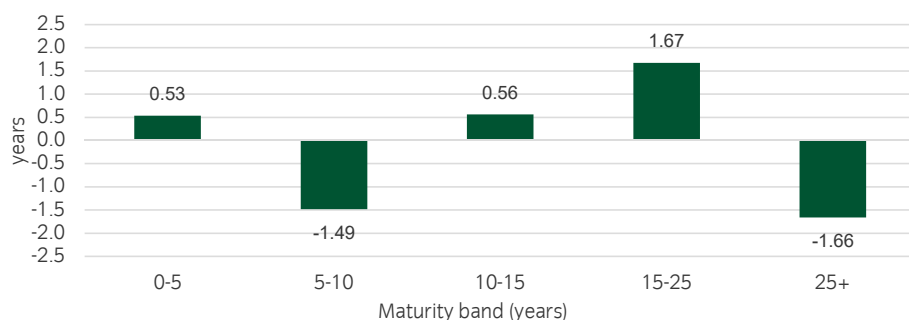

DURATION EXPOSURE BY MATURITY

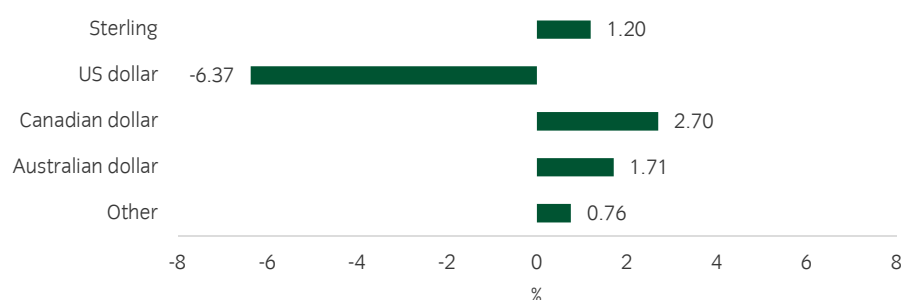
