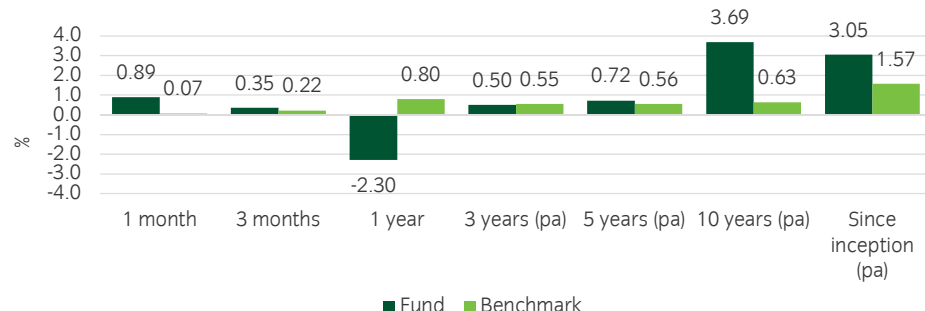
FUND OBJECTIVE

The Fund aims to deliver positive absolute returns on an annual basis

FUND SUMMARY

- Actively managed to aim to deliver positive absolute returns in excess of a cash benchmark
- Invests primarily in fixed income securities and currencies, either directly or via derivatives, to express views on the direction of global bond and currency markets.
- Seeks to add value through a diversified portfolio incorporating positions in global bond and currency markets; aims to achieve attractive risk-adjusted returns in all market conditions.
- Rigorous and disciplined investment process bringing together the 'best ideas' from a large team of fixed income and currency specialists.

FUND MANAGER COMMENTS

The Fund delivered a positive return in March, outperforming its cash benchmark. Country allocation was positive for returns. Our long duration-neutral position in the US versus Germany contributed positively but was partially offset by a negative from our long Germany versus Italy position. Our long UK gilts versus Germany position was a small positive contributor while our long Canada versus US was a small negative – we closed out both of these positions during the month. Our remaining 30-year US Treasury Inflation-Protected Securities 'breakeven' position, which is much reduced in size, was a negative contributor to performance during March. Yield curve positioning was modestly positive. In credit, investment grade, high yield, loans and asset-backed securities all contributed positively. Our emerging market debt allocation was positive due to the rally in local rates duration. Currency positioning was neutral.

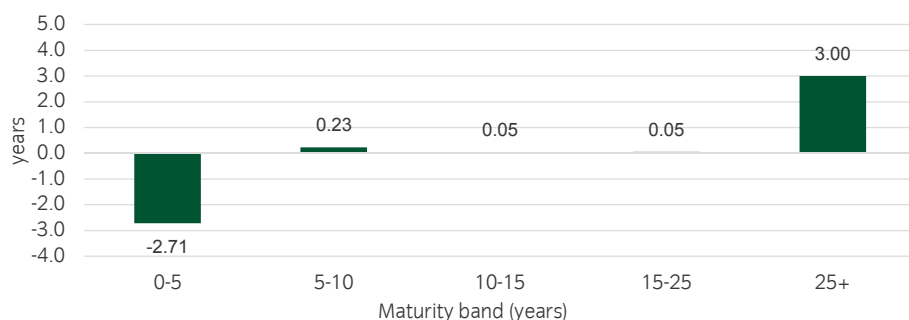

DURATION EXPOSURE BY MATURITY

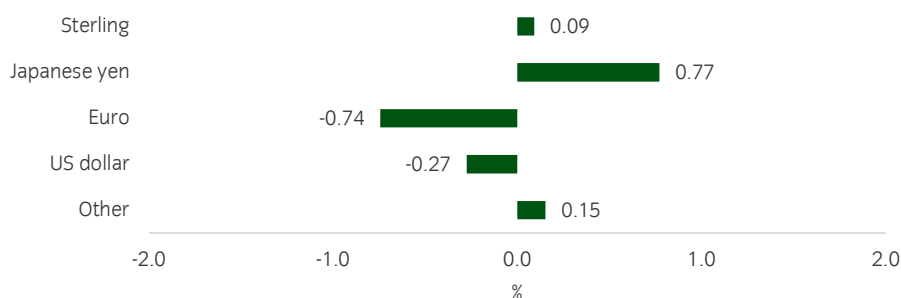
