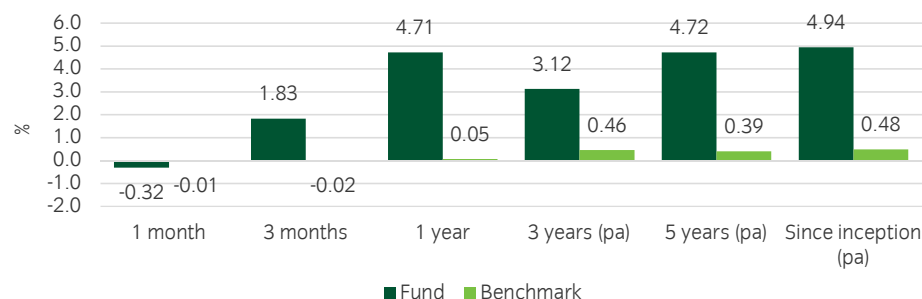

FUND MANAGER COMMENTS

With the economic recovery in sight, reflation became the market focus, driving bond yields higher. Pro-cyclical assets started the month strongly, anticipating stronger growth, but market action became choppy as the rise in yields intensified. Against this backdrop, the portfolio recorded a negative return. Although we had reduced duration in anticipation of just such an event, our remaining exposures in government bonds and to a lesser extent investment grade credit detracted from returns. Our equity holdings gained, and performance was further boosted by positions designed to benefit from global equity market laggards such as the UK catching up. Within real assets, energy and industrial metals surged, pushing our commodity holdings higher, but this was offset by a negative performance from infrastructure holdings. We tactically added option-based structures to take advantage of elevated volatility premium, creating wide ranges within which we could profit.

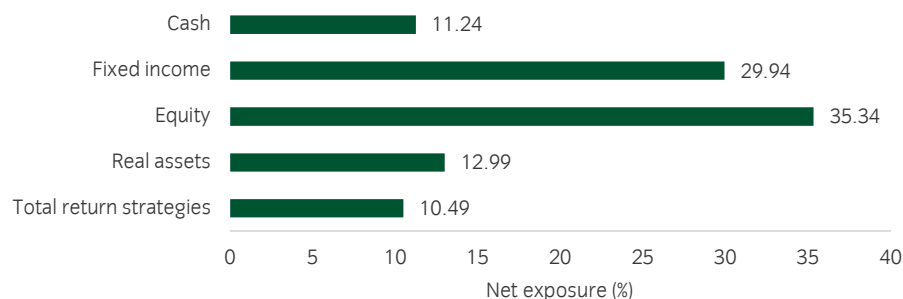
5 YEAR ANNUALISED GROSS PERFORMANCE (%)

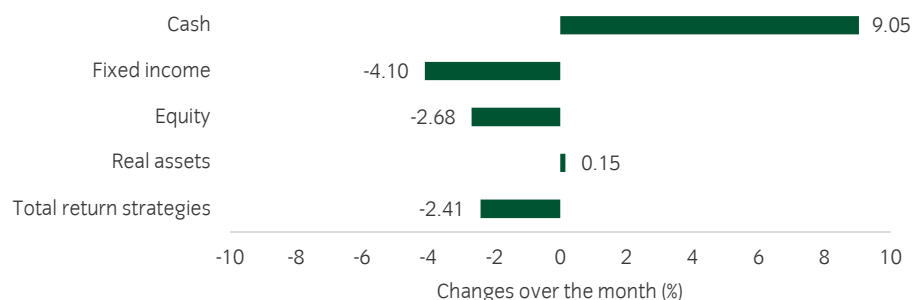

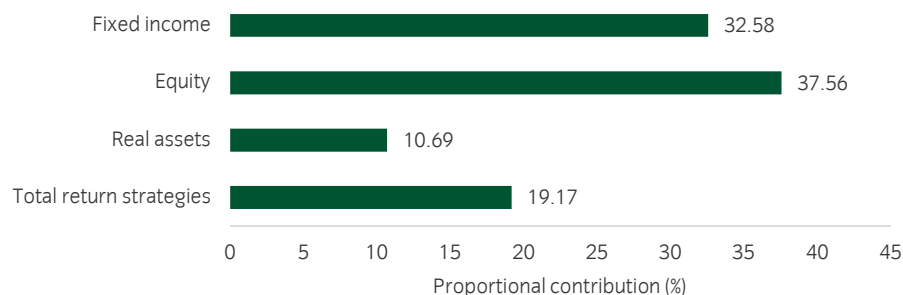
FUND ALLOCATION
