The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks

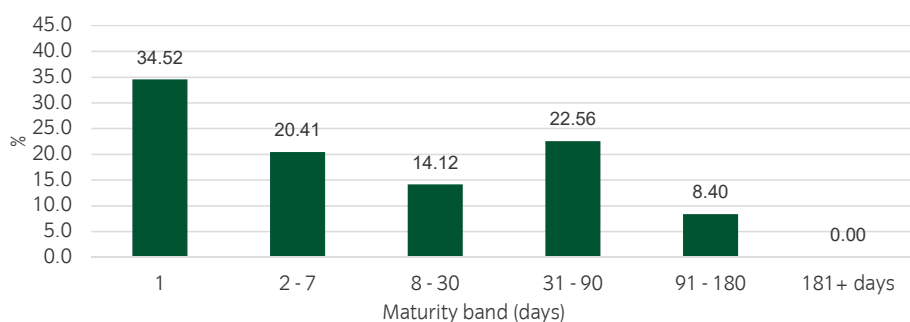

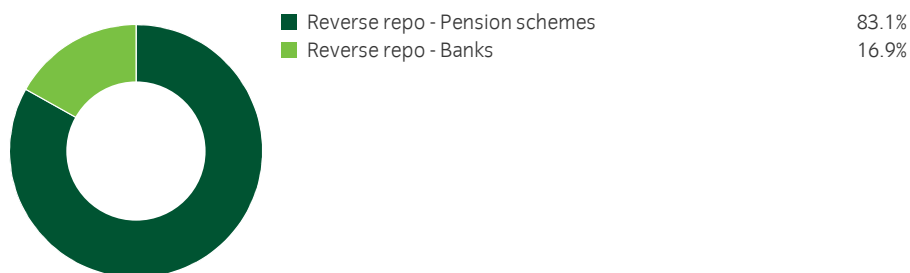
FUND MANAGER COMMENTS

The Bank of England (BoE) made no changes to its monetary policy over July. But the bank's monetary policy committee members voiced a difference of opinion on the direction of future policy decisions, with GDP growth balanced against inflation. UK annual consumer price inflation (CPI) rose for the fourth consecutive month and was reported at 2.5% over June. The UK Purchasing Managers' Index (PMI) declined to 60.4 in July, demonstrating the slowest pace of expansion within the sector since March. In markets, 1-month sterling LIBOR was flat at 0.05% in July, while the 3-month rate was flat at 0.07%. In gilt markets, 2-year gilt yields were flat at 0.05%, while 5-year gilt yields declined from 0.33% to 0.27%. With interest rates set to remain at ultra-low levels for the foreseeable future (unless inflation notably picks up), fund activity focused on quarter end and year end positions. The weighted average maturity of the Fund was 20 days at the end of June and 31 days at the end of July.
