## FUND OBJECTIVE

The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

## FUND SUMMARY

- Actively managed to aim to deliver security, liquidity and attractive cash yields comparable to short-dated money market interest rates
- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks
- Fitch rated AA Af/S1, Moody's rated Aaa-mf
- Qualifying Money Market Fund (QMMF) for regulated Client Money. Investors should make their own independent determination as to whether the Fund meets the QMMF criteria before investing

## FUND MANAGER COMMENTS

UK annual inflation was slightly lower in September at 3.1% but remains above the Bank of England (BoE)'s target. The BoE held no monetary policy meetings over the month so no changes to interest rates were made. With oil prices rising, transport-related costs were a major contributor to inflation. UK factory activity increased slightly as the manufacturing purchasing managers' Index (PMI) rose from 57.1 in September to 57.8 in October. In markets, 1-month sterling LIBOR rose from 0.05% in September to 0.13% in October, while the 3-month rate increased from 0.08% to 0.23%. In gilt markets, 2-year gilt yields rose from 0.42% to 0.70%, while 5-year gilt yields increased from 0.64% to 0.84%. With the potential for interest rates to rise in the near future, fund activity was limited to short-dated assets to position for any hike. The weighted average maturity of the Fund was 32 days at the end of September and 44 days at the end of October.

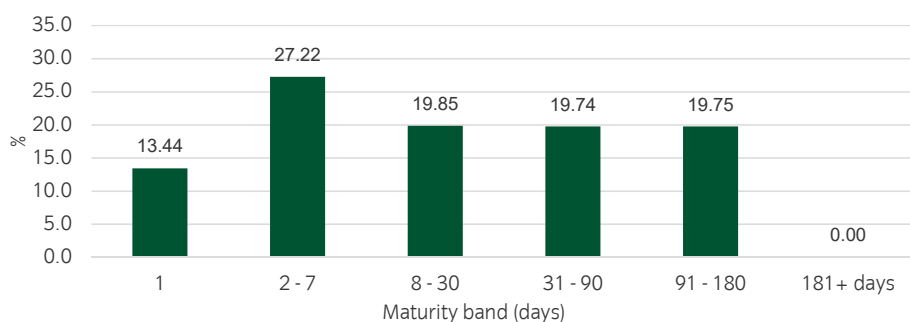

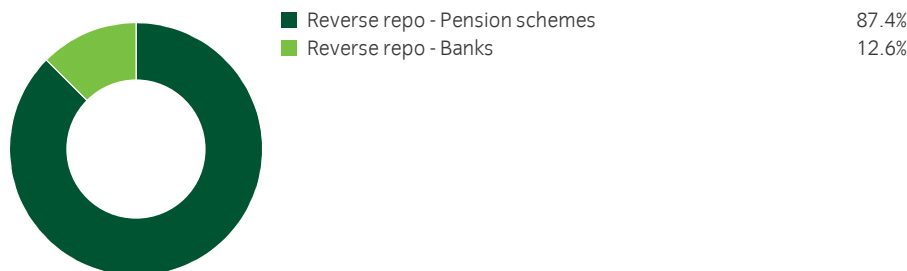
