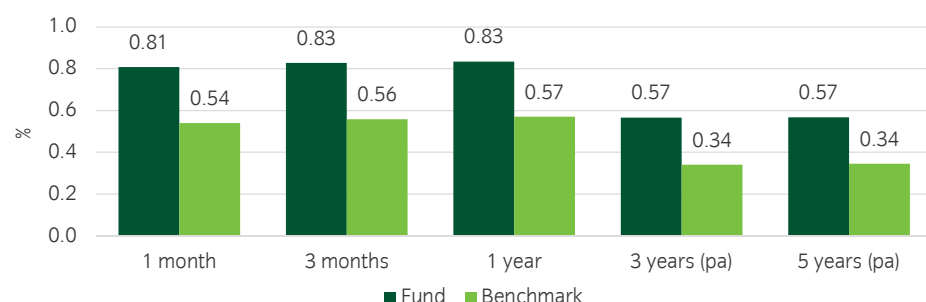
FUND OBJECTIVE

FUND MANAGER COMMENTS

The Bank of England (BoE) voted to leave interest rates unchanged but downgraded growth forecasts for 2019 and 2020 to 1.3%, down from 1.5% and 1.6%, respectively. Inflation rose 2.1% year-on-year in July, beating expectations of 1.9% and surpassing the BoE's 2% target. Regarding Brexit, Prime Minister Boris Johnson's request to suspend Parliament for up to five weeks starting in mid-September was approved by the Queen. In markets, 1-month sterling Libor was unchanged at 0.71% while the 3-month decreased from 0.77% to 0.76%. In gilt markets, yields fell: 2-year gilt yields from 0.44% to 0.40%, and 5-year gilt yields from 0.38% to 0.33%. We added names including Pohjola, Sumitomo Mitsui Banking Corp, Mitsubishi and Credit Agricole to the certificate of deposit and commercial paper portfolio. We also added floating-rate notes issued by Rabobank. We also added short-dated UK government bonds. The Fund's weighted average maturity increased 34 to 39 days over the month.

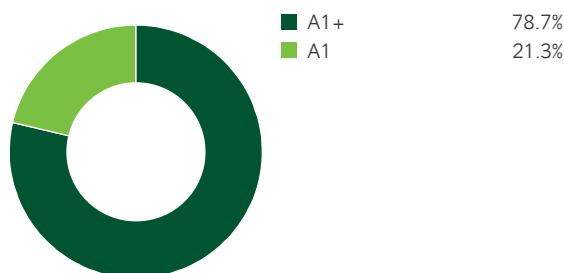

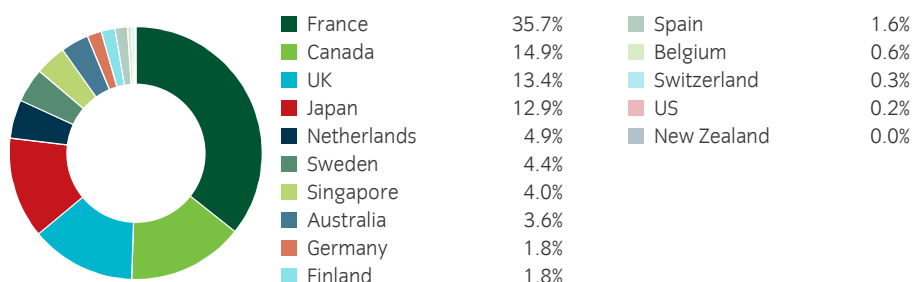

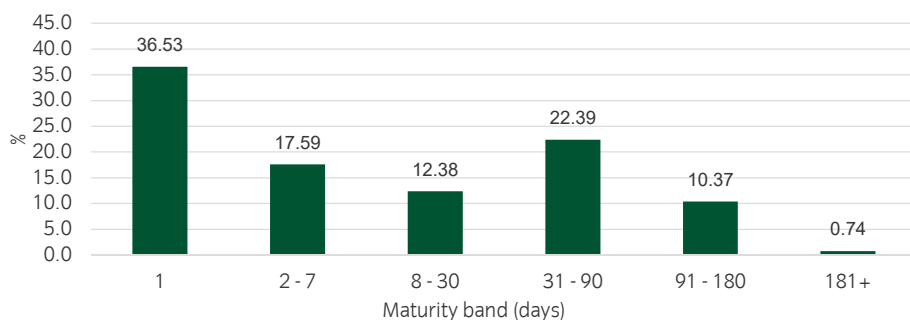

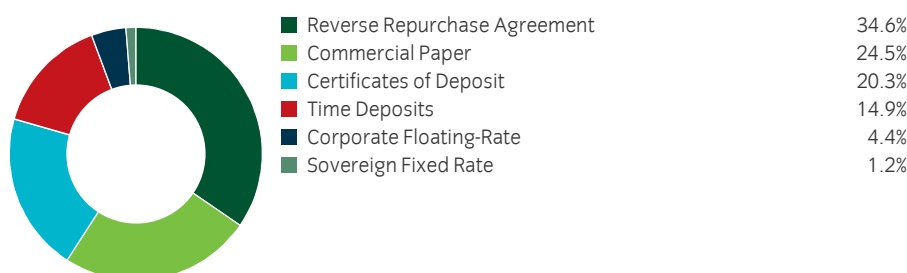
