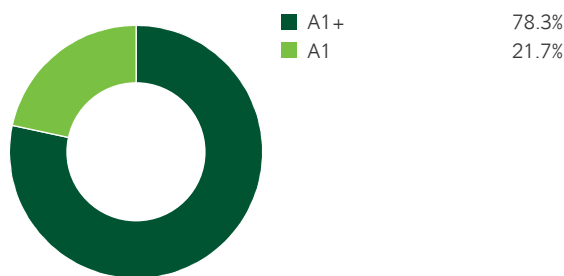

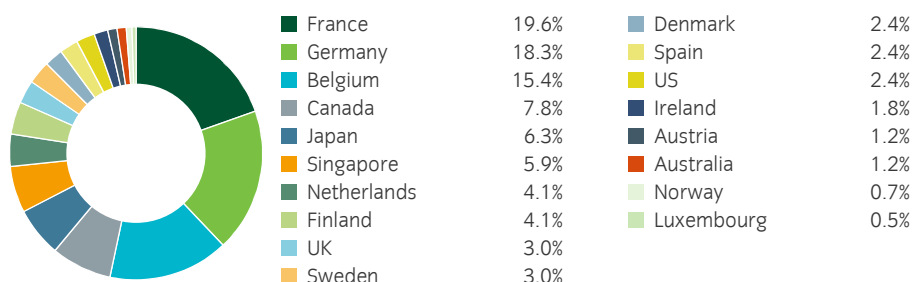
FUND MANAGER COMMENTS

The US Federal Reserve (Fed) kept the federal funds rate target range at 0-0.25% over March. The Fed also maintained its monthly purchases of at least \$80 billion of Treasury securities and \$40 billion of mortgage-backed securities. However, Jerome Powell, the Fed's chair, reiterated that the central bank remains willing to use all tools available to support economic growth. The IHS Markit Flash US Manufacturing PMI rose from 58.6 in February to 59.0 in March. Meanwhile, US annual CPI was reported at 1.7% in February while retail sales fell 3% month-on-month. In markets, 1-month US dollar LIBOR fell from 0.12% to 0.11% over March, while the 3-month rate remained at 0.19%. With interest rates set to remain at ultra-low levels for the foreseeable future (unless inflation notably picks up), fund activity was limited to very short-dated assets. The weighted average maturity of the Fund was 25 days at the end of February and 23 days at the end of March.

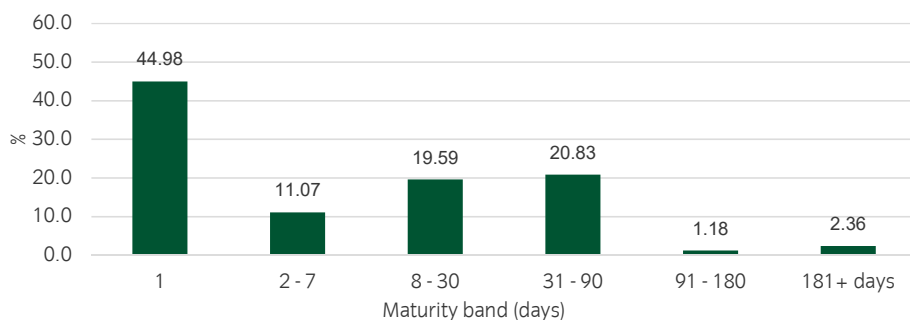

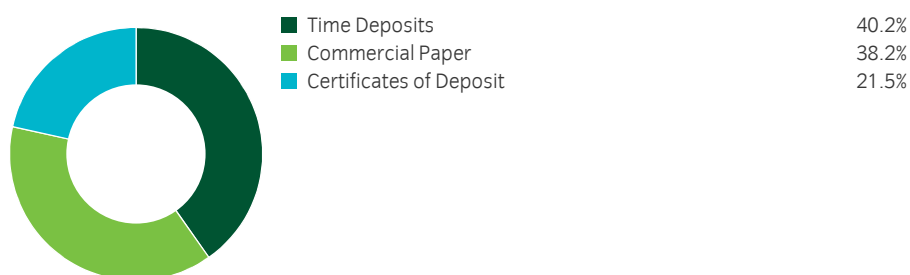
GEOGRAPHY
