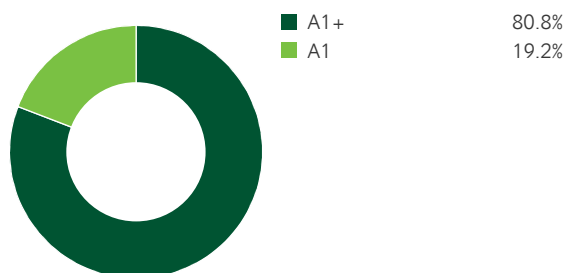

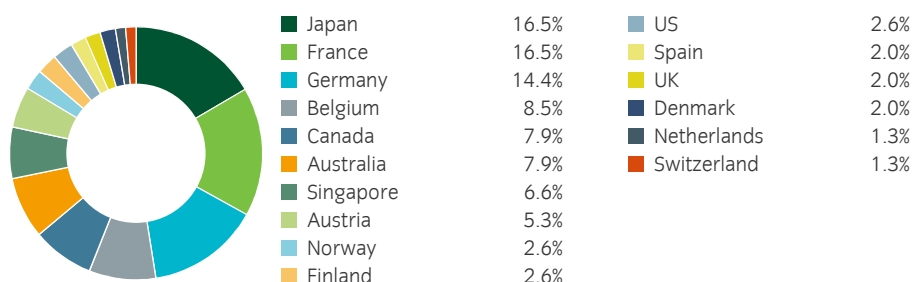
FUND MANAGER COMMENTS

The US Federal Reserve (Fed) held the target range for its Fed funds rate at 0-0.25%. The Fed also left asset purchases unchanged at \$80 billion of Treasuries and \$40 billion of mortgage-backed securities per month. Annual core Personal Consumption Expenditure prices rose by 3.4% in May. Fed officials reiterated that higher inflation is "transitory" and due to a combination of supply bottlenecks, rising commodity prices, and central bank stimulus. Though the Fed said that no policy tightening would occur in the near term, two interest rate increases are expected to occur by the end of 2023. In markets, 1-month US dollar LIBOR rose from 0.09% to 0.10% over June, while the 3-month rate increased from 0.13% to 0.15%. With interest rates set to remain at ultra-low levels for the foreseeable future (unless inflation notably picks up), fund activity was limited to very short-dated assets. The weighted average maturity of the Fund was 27 days at the end of May and 25 days at the end of June.

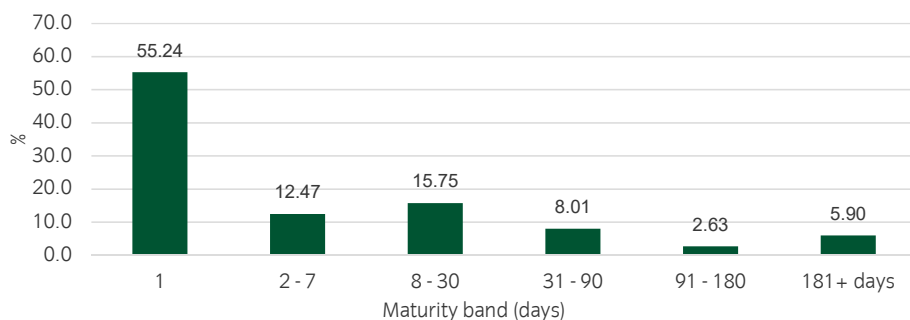

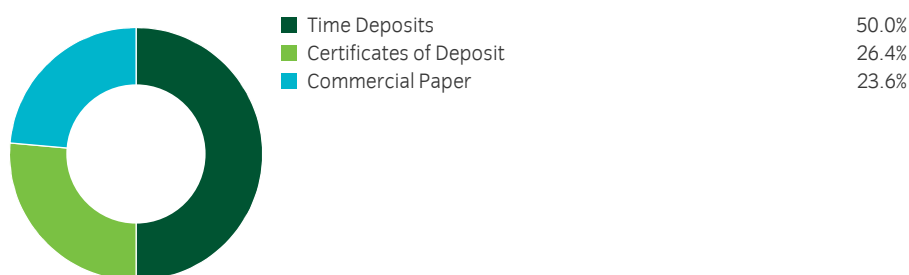
GEOGRAPHY
