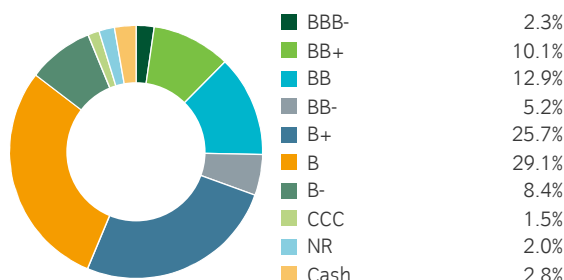

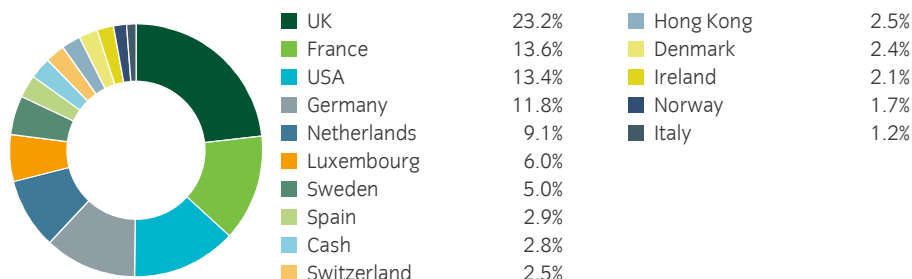
FUND MANAGER COMMENTS

The Fund generated a positive return in March and outperformed the CS Western European Institutional Loan Index. It was the busiest month in the European leveraged loan primary markets since the Global Financial Crisis as borrowers continued to reduce their cost of borrowing and term out maturities. This weighed on the secondary market. The collateralised loan obligation market closed out its busiest quarter on record. The index's distress ratio fell from 0.93% in February to 0.92% in March, with the default rate down from 2.1% to 2.0%. We bought the Busy Bees, Foncia, Ion Trading, and Casino new issues. In the secondary market, we sold our remaining SGB-SMIT Group holding. Loan demand remains strong. However, there is still uncertainty regarding the easing of pandemic-related restrictions and the rollout of vaccines in Europe is lagging the UK and US. We will invest selectively in businesses with decent cashflow generation, and tactical opportunities in riskier/more cyclical names.

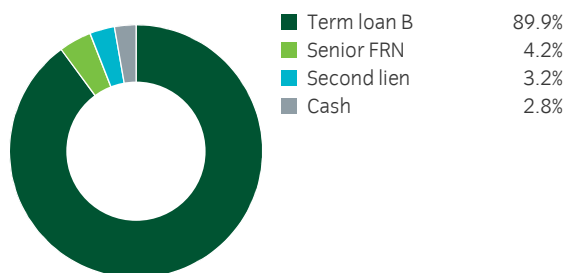
GEOGRAPHY
