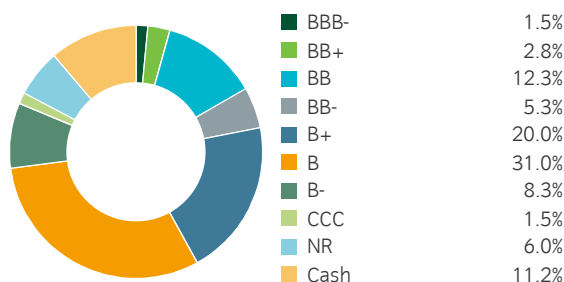

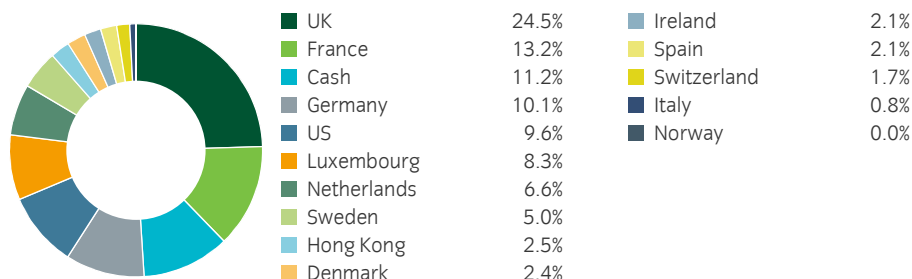
## FUND MANAGER COMMENTS

The Fund generated a positive return in April but underperformed the CS Western European Institutional Loan Index. Monthly volumes took a step back after a busy March, in which the European leveraged loan primary market saw the largest amount of issuance since before the Global Financial Crisis. Private equity sponsors' eagerness to put cash to work drove a fresh surge of acquisition financing. The index's distress ratio fell from 0.92% in March to 0.72% in April, with the default rate down from 2.0% to 1.8%. We bought the IVC, Cooper, UPC/Sunrise, Logoplaste and Lonza new issues. In the secondary market, we sold Avantor and Biogroup. There is uncertainty about virus mutations, the easing of pandemic-related restrictions, and vaccine rollouts, but the market's tone is positive with travel and leisure names rallying on further talk of reopening in Europe. We will invest selectively in businesses with decent cashflow generation, and tactical opportunities in riskier/more cyclical names.

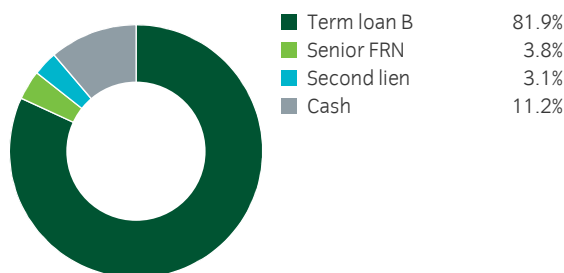
## GEOGRAPHY
