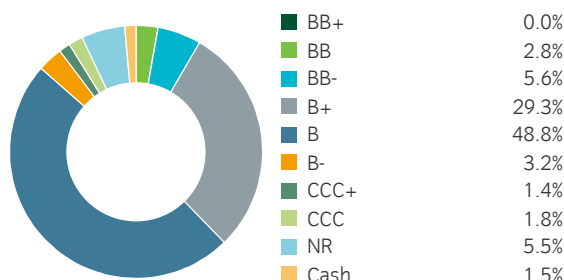

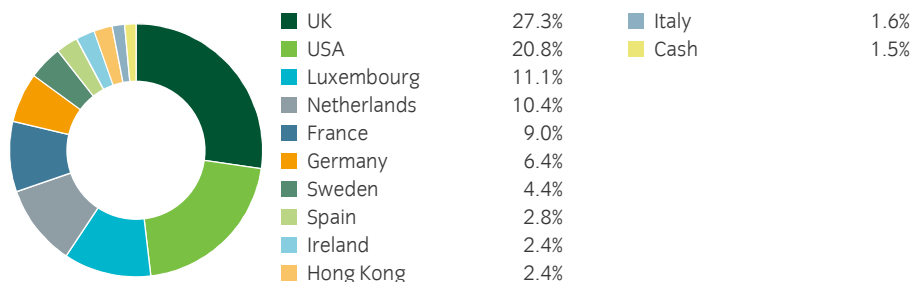
FUND MANAGER COMMENTS

The Fund generated a negative return in February but outperformed the CS Western European Institutional Loan Index. Against a resilient January, the leveraged loan market suffered from risk-off contagion in February. Primary supply was limited. The index's default ratio increased from 0.6% to 0.8%, while the distress ratio rose from 0.36% to 0.66%. In the primary market, we bought Caldic and Cheplapharm. In the secondary market, we cut T-Mobile Netherlands and Autodis, and exited Diaverum and Babilou. The impact of Russia's war on Ukraine is still being digested by market participants but volatility will persist for some time. The Fund has very limited exposure to either Russia or Ukraine. Loans have proved remarkably resilient, dramatically outperforming other asset classes. We continue to monitor our portfolio companies to ensure they are managing supply chain disruptions and higher input/energy cost inflation. However, the leveraged loan technical picture remains extremely robust.

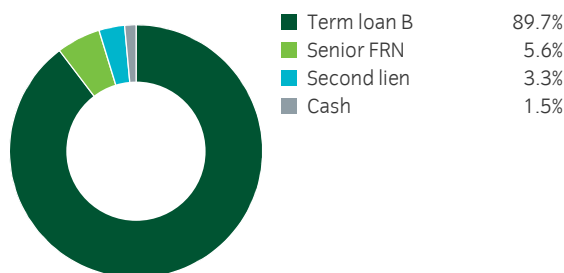
GEOGRAPHY
