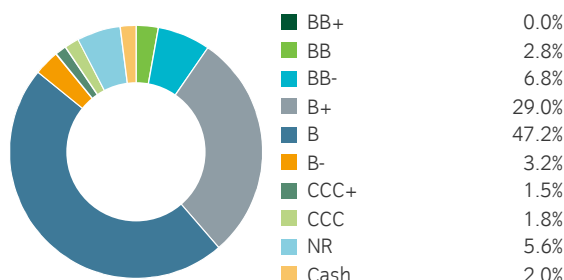

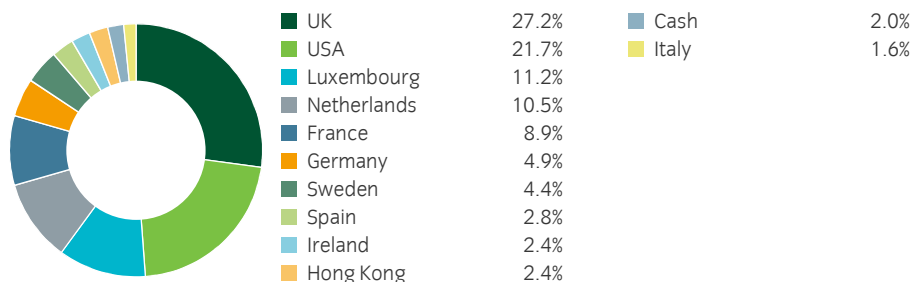
FUND MANAGER COMMENTS

The Fund generated a positive return in March and outperformed the CS Western European Institutional Loan Index. After a weak start to the month, the leveraged loan market recovered strongly in the second half. Technical factors remained supportive. The index's default ratio remained at 0.8%, while the distress ratio rose from 0.66% to 1.06%. In the primary market, we bought SRM Concrete. In the secondary market, we exited Kloeckner Pentaplast. Primary issuance has slowly restarted, while demand remains robust. Loans have shown remarkable resilience, dramatically outperforming other asset classes. The floating-rate nature of the loan asset class should continue to provide insulation and drive performance. We think that current spreads and original issue discounts for high single B risk look attractive. However, we remain cognisant of supply-chain disruptions, input/energy cost inflation, and the second and third order effects of Russia's invasion of Ukraine so will invest selectively.

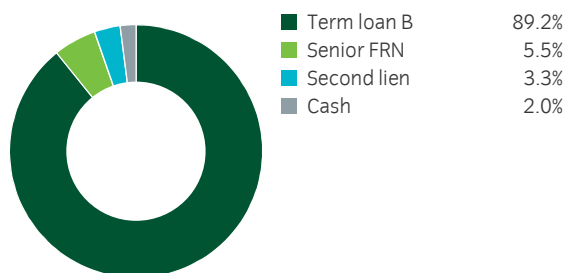
GEOGRAPHY
