FUND MANAGER COMMENTS

The UK's annual inflation rate fell to 7.9% in June due to falling fuel prices, down from 8.7% in May. Core inflation also declined from 7.1% in May to 6.9% in June. The UK's unemployment rate rose to 4% in the three months to May, the highest level since the final quarter of 2021. The manufacturing purchasing managers' index declined from 46.6 in June to 45.3 in July, the 12th consecutive month of contraction. In markets, SONIA remained at 4.93%, while the 2-year gilt yield declined from 5.27% to 5.07% and the 5-year gilt yield decreased from 4.66% to 4.47%. Fund activity was centred around positioning for central bank meetings. We will continue to position for further central bank rate hikes, with risks around the stickiness of inflation. The weighted average maturity of the Fund was 14 days at the end of June and 9 days at the end of July.




