FUND MANAGER COMMENTS

The Bank of England left the Bank Rate unchanged at 4.5% on 20 March, in part at concerns over inflation rising. However, a week later it was announced that annual inflation had declined to 2.8% in February, falling back from 3.0% in January. The economy expanded by 0.1% in the fourth quarter of 2024. The Manufacturing Purchasing Managers' Index declined from 46.9 in February to 44.6 in March, while the Services Purchasing Managers' Index rose from 51.0 in February to 52.5 in March. In markets, SONIA remained at 4.45%, the 2-year gilt yield rose marginally from 4.19% to 4.20% and the 5-year gilt yield increased from 4.20% to 4.32%. Positioning will be determined by central bank meetings.


