FUND MANAGER COMMENTS

The Bank of England Monetary Policy Committee (MPC) voted to maintain the Bank Rate at 4% by a 7-2 margin. Consumer Price Inflation rose by 3.8% in August, the same rate seen in July. The Manufacturing Purchasing Managers' Index declined from 46.2 in September from 47.0 in August. The UK economy expanded by 0.3% in the second quarter following a 0.7% increase in Q1. In markets, SONIA remained at 3.97%, the 2-year gilt yield rose from 3.95% to 3.99% and the 5-year gilt yield increased from 4.10% to 4.13%. Fund activity focused on maturities out to three months where the fund was able to add positions at benchmark plus returns. With the MPC expected to be on hold until after the budget, term levels offered some value at the margin as expectations of further cuts were pushed into 2026.




