FUND OBJECTIVE

The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

FUND SUMMARY

- Actively managed to aim to deliver security, liquidity and attractive cash yields comparable to short-dated money market interest rates
- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks
- Fitch rated AA Af/S1, Moody's rated Aaa-mf
- Qualifying Money Market Fund (QMMF) for regulated Client Money. Investors should make their own independent determination as to whether the Fund meets the QMMF criteria before investing

FUND MANAGER COMMENTS

The Bank of England kept interest rates unchanged, in line with market expectations. It was a close decision as four of the nine members of the Monetary Policy Committee voted to cut rates. Inflation declined slightly, with the headline rate falling to 3.0% and the core rate to 3.1%. The 2-year gilt yield fell by 19bp to 3.52%, while the 5-year gilt yield fell 27bp to 3.68%. Activity in the portfolio focused on short-dated maturities out to three months. The escalation in geopolitical events at month end has led to increased uncertainty on central bank policy, so a cautious approach to term investment will be adopted.




