FUND OBJECTIVE

The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks
- Fitch rated AAAsf/S1, Moody's rated Aaa-mf

FUND MANAGER COMMENTS

At its June meeting, the Bank of England Monetary Policy Committee voted 7-2 to maintain Bank Rate at 3.75%. Inflation remained broadly stable over the period, with headline CPI holding at 2.8% while core inflation edged up to 2.6%. Gilt yields moved modestly lower over the month, with the 2-year gilt yield declining to 4.16% and the 5-year yield falling to 4.30% by the end of June. With tensions in the Gulf easing and agreements for a peace deal in place in principle between the US and Iran, markets began to reprice rate hike expectations as the price of oil fell and inflationary pressures eased. Activity across the month focused on shorter dated maturities to retain a high level of short date liquidity, the exception being the purchase of the March 2027 gilt which offered reasonable value for fixed rate investment.

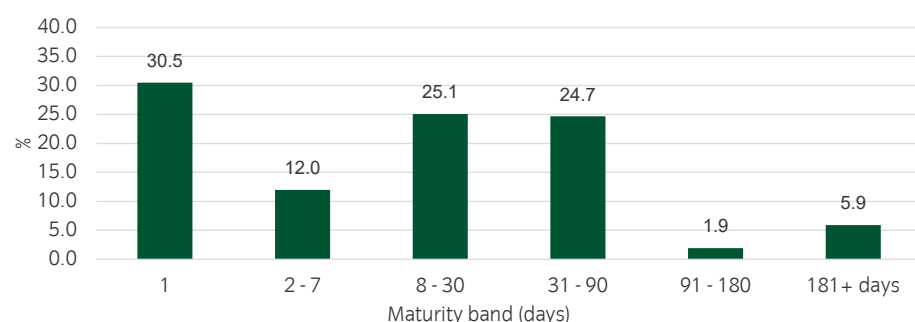

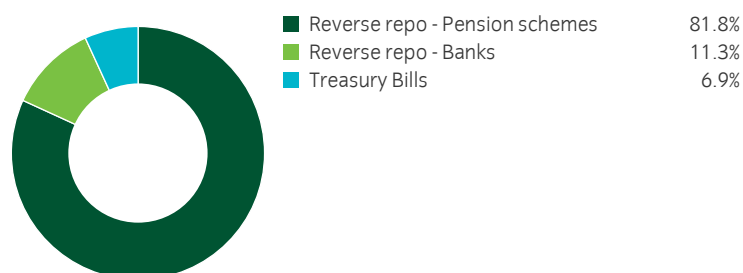
