The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks

FUND MANAGER COMMENTS

UK inflation surprised to the upside during August, with data released during the month showing the annual CPI inflation rate rose to 2.9% in July from 2.6% in June. Investors subsequently reassessed the outlook for Bank of England policy, reducing expectations for near-term monetary easing. Gilt yields moved higher over the month, with the 5-year gilt yield rising to 4.62% by month-end. Activity in the portfolio centred on short dates. Ongoing uncertainty fuelled by geopolitical events meant the fund retained a high level of short-dated liquidity to take advantage of any change in market pricing.

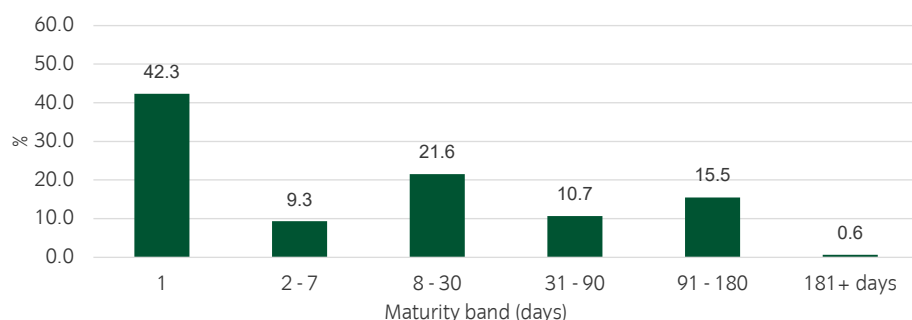

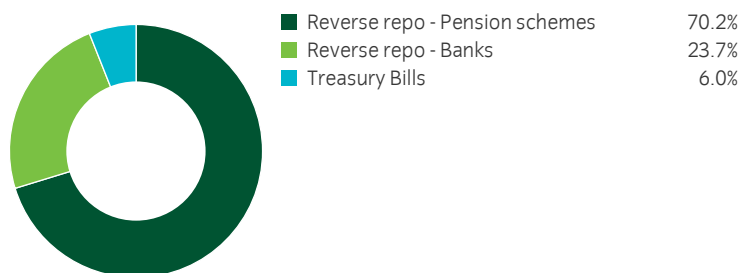
