FUND MANAGER COMMENTS

The Fund generated a positive return in August. Risk free assets were volatile and credit spreads widened. The Fund's credit positioning was neutral. Our long positions in loans and asset-backed securities contributed. Our long positions in European investment grade credit relative to European high yield credit and US investment grade credit were negative. Country selection proved detrimental, owing to our relative short position in Europe against long positions in other markets. Our emerging market positions detracted, due to rising yields. The Fund's swap spread position was a negative. Our yield curve positioning had a positive impact on performance, driven by the steepener position in UK interest rate swaps. The Fund's duration positioning detracted, due to our long position in US Treasuries. Our inflation positions had a positive impact on performance, resulting from our short position in euro-denominated inflation swaps. The Fund's currency positioning was neutral.


