
FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark and the CS Western European Institutional Loan Index during the month and extended its outperformance on a year-to-date basis. In May, leveraged loans continued to rally due to better-than-expected corporate earnings and new issues of collateralised loan obligations. The index's default ratio remained at 0.6%, while the distress ratio decreased from 3.4% to 3%. Issuance was subdued and amounted to just €450 million. This year's issuance is expected to fall well below 2022's level. We did not participate in any new issues. We sold the Constellation Automotive second lien facility due to credit concerns. Rising coupons and capital gains should support our returns. In our view, leveraged loans are well placed to compensate for credit risk and now offer select investment opportunities. We will continue to use the current opening to increase the Fund's carry and rotate into defensive companies with higher margins.
