
FUND MANAGER COMMENTS

The Fund had another strong month, ending the year with the highest total return since inception. The Fund also outperformed the cash benchmark and ended the year ahead of the CS Western European Institutional Loan Index. In December, leveraged loans recorded further gains. The European Leveraged Loan Index registered the best year-to-date performance since 2009. The European default ratio remained at 1.4%, while the distress ratio fell from 4.26% to 2.53%. Issuance in 2023 amounted to €28 billion, below 2022's levels. We did not trade in December. Leveraged loans have outperformed the global credit space and are still supported by robust technicals, limited supply, and strong formation of collateralised loan obligations. However, we are also mindful of slower forecasted growth, deteriorating corporate fundamentals and other idiosyncratic headwinds. We will continue to use the current opening to increase the Fund's carry and rotate into defensive companies with higher margins.


