FUND MANAGER COMMENTS

The eurozone annual inflation rate remained unchanged at 5.3% in August, as energy prices fell at a reduced pace. Annual core inflation moderated by 20 basis points to 5.3%. A second estimate of eurozone second-quarter GDP growth was unchanged at 0.3%, while unemployment was unchanged at a record low 6.4% in July. The eurozone's manufacturing purchasing managers' index rose to 43.5 in August from 42.7 in July. In markets, 1-month EURIBOR rose from 3.58% to 3.64% over August, while the 3-month rate increased from 3.71% to 3.79%. Fund activity was centred around positioning for central bank meetings. We will continue to position for further central bank rate hikes, with risks around the stickiness of inflation. The weighted average maturity of the Fund was 33 days at the end of July and 28 days at the end of August.






