
FUND MANAGER COMMENTS

Eurozone inflation declined from an annual rate of 2.9% in October to 2.4% in November, according to a flash estimate, reaching the lowest level since July 2021. A second estimate confirmed that GDP in the eurozone contracted by 0.1% over the third-quarter. The manufacturing purchasing managers' index rose from 43.1 in October to 44.2 in November, but output, new orders and export sales all continued to decline. In markets, 1-month EURIBOR remained at 3.87% over November, while the 3-month rate declined slightly from 3.97% to 3.96%. We added certificates of deposit and commercial paper from Nordea, Svenska Handelsbanken and Bank of Montreal. We bought floating-rate notes from OP Corporate Bank. While the inflation outlook appears positive and markets are pricing no further rate hikes, selective term investments are being sought, especially over year end. At the same time positioning will focus on upcoming central bank meetings. The weighted average maturity of the Fund was 52 days at the end of October and 60 days at the end of November.


